Thank you for your request for information, which has been considered under the terms of the Freedom of Information Act (FOIA) 2000.

In your email you ask for the following information:

I would like to request information about the the size of the electorate for each constituency, based on current (from 2010 election) boundaries. By this I do not mean the proposed 2018 boundaries.

The alphabetical list of each current UK parliamentary constituency in England with the size of the electorate in each between December 2009 and December 2016 - the last date the electorate figures were published - is already published on the Commission's website. You can access the information under the heading 'Historic electorate data' on the 'Data and resources page' of our website: <http://boundarycommissionforengland.independent.gov.uk/data-and-resources/>

We do not hold the information on the composition of current constituencies in the other constituent parts of the United Kingdom, for which you should contact the respective Commissions in Scotland, Wales and Northern Ireland. You can contact each Commission via the following email addresses:

The latest statistics for the size of the UK electorate were published on 17 March 2017 by the Office for National Statistics (ONS) and are based upon the electoral register published on the 1 December 2016. It is unlikely there will be a further publication of these statistics before the General Election on the 8 June 2017. However figures for the UK electorate are likely to change before then as individuals are able to register their vote up to 11:59 Monday 22 May 2017. For more up to date data than 1 December 2016 please contact the Electoral Commission.
