## 2016-17 FOI 0019

Dear

Thank you for your request for information, which has been considered under the terms of the Freedom of Information Act (FOIA) 2000.

In your email you ask for the following information:

Please would you provide a list of the ten initially proposed constituencies that received the most comments in the first round of comments that ended on 5<sup>th</sup> December 2016 – ie the top ten? If it is necessary to invoke the Freedom of Information legislation, please regard this as a Freedom of Information request.

The Boundary Commission for England (BCE) does not hold the information you request, as the responses we have received as part of the consultation processes are recorded in relation to existing - rather than initially proposed - constituencies. The BCE has taken this approach because the existing constituencies are a fixed entity throughout the review, whereas proposed constituencies may - and in many instances do - change during the course of the 2018 Review.

Should you be interested in which <u>existing</u> constituencies received the most comments during our initial consultation, the data to enable you to see this is publicly available by downloading a CSV of the representations from the BCE consultation website <u>www.bce2018.org.uk</u> and filtering appropriately. Nevertheless, under the FOIA duty to advise and assist, we have used that data to provide you with the following table, which shows the top ten existing constituencies by number of individual representations received about that constituency:
