Thank you for your request for information, which has been considered under the terms of the Freedom of Information Act (FOIA) 2000.

In your email you ask for the following information, which I have numbered for ease of reference:

- 1. How large is your organisation in terms of employees? An estimate is acceptable thank you.
- 2. What is your single Corporate Objective, or how you would describe your reason for existing?
- 3. What role does Technology play in supporting that objective?
- 4. Do you have a Chief Information Officer or Chief Technology Officer and could you tell me how best to contact them please?
- 5. Do you have an IT Strategy and/or Digital Strategy and if so could you share them please?
- 6. Are you part of a larger organisation or government body, and if so who?

The response to your request is as follows:

- 1. There are 16 staff currently working within the Boundary Commission for England (BCE), plus one current vacancy, due to be filled shortly.
- 2. The BCE's purpose is to "keep under review the representation [of England] in the House of Commons", in line with the rules set out in the Parliamentary Constituencies Act 1986 (as amended). In broad terms, this currently means conducting a 'whole-England' review of constituencies once every five years, with a primary purpose of achieving broad parity in the number of electors in each constituency.
- 3. For general administration, the BCE uses the technology platform operated by the Cabinet Office (see question 6 below). We use a bespoke version of open-source QGIS Geographic Information Software to build and illustrate various constituency boundary options, and a purpose-built consultation website to facilitate the various phases of public consultation during the review, further supporting that consultation with a separate 'corporate' website, social media accounts, and digital advertising.
- 4. The BCE does not have its own CIO or CTO (see question 6 below).
- 5. The BCE does not have its own IT and/or Digital Strategy (see question 6 below).
- 6. The BCE is an advisory non-departmental body sponsored by the Cabinet Office. As such, while the core policy decisions and recommendations about constituencies are made by our independent Commissioners, the BCE's staff, equipment and administrative policies are provided by
