Thank you for your representation to the Boundary Commission for England (BCE). As per the e-mail of the 7 December, the BCE are treating part of your representation as a request for information under the Freedom of information Act 2000 (FOIA 2000). The part under consideration is as

(a) Make public all internal documentation relating to the planning and production of initial and revised proposals for the West Midlands, including reports, memorandums, drafts, notes and summaries, records of meetings, results of computer modelling, maps, correspondence, and e-mails between staff.

We have carried out a search for materials relating to your request and have identified the documents in the table below that are in scope. The final column of the table indicates our decision in relation to release of each category of information.

Section 22 of the FOIA 2000 provides public authorities with an exemption from the disclosure of information that is intended for publication at a future date, where it is reasonable in all circumstances that information should be withheld from disclosure until that date, as the Commission has committed to publish these documents following its completion. These records constitute information intended for future publication and the Commission is therefore entitled to consider their exemption from what would constitute early disclosure. Following consideration of the arguments both for and against the disclosure of the records, the Commission's qualified person (the Secretary of the Commission) has concluded that the case for maintaining this exemption outweighs the public interest in advance of the pre-determined publication date (the end of the Review in September 2018).

Section 36 of the FOIA 2000 provides public authorities with an exemption from the disclosure of information that is likely to inhibit the free and frank provision of advice or the free and frank exchange of views for the purposes of deliberation. In the opinion of the Commission's qualified person, release of the relevant information above would be likely to affect detrimentally the Commissioners', Assistant Commissioners' and the Secretariat's ability to consider, discuss and deliberate over different and alternative options for Parliamentary constituencies. This is turn may have a negative effect on the final recommendations that the Commission puts to the Government in September 2018.
