Initial/revised proposals overview

1. The South West region was allocated 53 constituencies under the initial and revised proposals, a reduction of two from the existing allocation. In formulating the initial and revised proposals the Commission decided to construct constituencies using the following sub-regions:

- 2. Under the initial proposals nine of the existing 55 constituencies were unchanged. The revised proposals retained 11 of the existing constituencies unchanged. Under both the initial and revised proposals it was proposed to have four constituencies that crossed county boundaries. We proposed one constituency which crossed both the Cornwall and Devon county boundaries, combining the towns of Bideford, Bude and Launceston to form a constituency of that name. In Dorset and Wiltshire we combined the towns of Warminster and Shaftesbury in a constituency of that name to form a cross-county constituency. We combined electors from the north-east of the County of Somerset with electors from Bath, and North East Somerset in one constituency called North East Somerset. Finally, we proposed that some electors from the County of Gloucestershire were combined with electors from the District of South Gloucestershire to form the Dursley, Thornbury and Yate constituency.
- In response to the consultation on the initial proposals and secondary consultation, the Commission received just over 2,000 representations regarding the South West region. These representations commented on most parts of the region, with the main issues being:
 - The proposed Bideford, Bude and Launceston ('Devonwall') cross-county constituency: respondents objected to the inclusion of wards from Cornwall in a cross-county constituency with Devon.
 - The constituencies in the Bournemouth and Poole area: respondents objected to changes made to the existing pattern of constituencies in Bournemouth and Poole.

- The constituencies in Gloucestershire: respondents opposed the division of Stroud between three constituencies, the inclusion of the two Quedgeley wards in the Stroud constituency and the inclusion of the seven southernmost wards from Stroud in the proposed Dursley, Thornbury and Yate constituency. They also objected to the inclusion of the Borough of Cheltenham ward of Springbank in the proposed Tewkesbury constituency, and change of constituency name from Forest of Dean to West Gloucestershire.
- 4. In considering the evidence received, the Commission altered 49% of constituencies in the South West region: five of these constituencies were only subject to a change of name.

Number of representations received

5. In the South West region, the Commission received a total of 952 representations during consultation on the revised proposals, bringing the total number of representations for this region to 2,971. This number included all those who gave evidence at the public hearings. There were also a number of duplicate representations within this total, as well as representations that made general comments that did not have any bearing on the substance of the initial proposals.

6. While many of the representations can be categorised as opposing the Commission's revised proposals, there has been a degree of support for certain constituencies across the whole region. These include, but are not limited to, both Bournemouth constituencies, Poole, Christchurch, Cheltenham, and within Wiltshire.

Campaigns

7. No campaigns were received for the South West region during consultation on the revised proposals. During the previous consultations the Commission received three campaigns.

Major issues

8. Major issues that drew objection in response to the revised proposals were as follows:

Bath and North East Somerset, and Somerset

• Somerton and Frome constituency: opposition to Frome remaining in its current constituency of Somerton and Frome.

Bournemouth, Dorset, Poole, and Wiltshire

- West Wiltshire, and North Wiltshire constituencies: objection to dividing the Parish of Box between these constituencies.
- Mid Dorset and Christchurch constituencies: opposition to splitting the town of Verwood between these constituencies.

Bristol

• There were no major issues that drew objection in this sub-region.

Gloucestershire, and South Gloucestershire

- Tewkesbury and Gloucester constituencies: objection to the Gloucester City wards of Elmbridge and Longlevens being included in the Tewkesbury constituency instead of the Gloucester constituency.
- Dursley, Thornbury and Yate, and Stroud constituencies: opposition to the wards of Cam West, Cam East, and Dursley being included in the proposed Dursley, Thornbury and Yate constituency.

Cornwall, Devon, Isles of Scilly, Plymouth, and Torbay

- Exeter, and East Devon constituencies: both opposition to and support for the Exeter City ward of St. Loyes being included in the Exeter constituency, rather than in East Devon where it is currently located.
- Bideford, Bude and Launceston constituency: opposition to this proposed cross-county constituency as it combines wards from the counties of Devon and Cornwall.

North Somerset

• There were no major issues that drew objection in this sub-region.

Swindon

• There were no major issues that drew objection in this sub-region.

Final recommendations

9. In light the of the representations and evidence received we have considered whether the revised proposals should be changed.

10. The final recommendations have been formulated on the same sub-regions used as the initial and revised proposals.

- 11. We received an alternative whole region scheme proposing substantial changes to Dorset that included two split ward solutions; splitting the South Gloucestershire District ward of Boyd Valley and the North Dorset District ward of Hill Forts. This counter-proposal suggested that the Shaftesbury area is combined with Salisbury to form a constituency, rather than Warminster (going across east/west). This proposal also substantially reconfigured the Poole, Bournemouth and Christchurch constituencies, even though we had received substantial support for the revised proposals for this region.
- 12. We also received a counter-proposal suggesting that Hampshire be included in a sub-region with Wiltshire, crossing the South West/South East regional boundary in an attempt to keep the ward of Chilworth, Nursling and Rownhams in the South East region constituency of Test Valley. Commissioners should note paragraph 20 (page 6) of the 'Guide to the 2018 Review of Parliamentary constituencies', which states that there would need to be 'very compelling reasons' for the Commission to depart from the region based approach to the current review.

13. All other representations have not proposed alternative sub-regions.

14. Under the final recommendations 11 of the existing constituencies are unchanged. As in the initial and revised proposals, four constituencies are proposed to cross county boundaries.

Overview

15. As part of our initial and revised proposals, we divided the South West region into seven sub-regions: Bath and North East Somerset, and Somerset; Bournemouth, Dorset, Poole and Wiltshire; Bristol; Cornwall, Devon, Isles of Scilly, Plymouth and Torbay; Gloucestershire and South Gloucestershire; North Somerset; and Swindon. In general, we received support for the creation of these sub-regions throughout all of the consultation periods. Some alternatives were put forward suggesting alternative sub-regions, however it was considered that these did not provide for a better pattern of constituencies.

16. As outlined previously in this paper, we recommend no changes to the sub-regions as part of the final recommendations.

Sub-region 1 - Bath and North East Somerset, and Somerset

- 17. Of the seven existing constituencies in this sub-region, four currently have electorates within the permitted electorate range. Of the remaining three constituencies, two (Bath, and North East Somerset) have electorates that fall below the 5% limit, and one (Bridgewater and West Somerset) is above the electoral range.
- 18. The initial proposals extended the existing Bath constituency by including the wards of Bathavon North, Bathavon South, and Peasedown. The constituency of Somerton and Frome lost the Ammerdown, and Coleford and Holcombe wards to the North East Somerset constituency. These wards joined four wards from the existing Wells constituency, bringing the town of Shepton Mallet into the proposed North East Somerset constituency. We also transferred the wards of Huntspill and Pawlett, and Puriton and Woolavington from the Bridgwater and West Somerset constituency to the Wells constituency. We were able to leave the constituency boundaries of Taunton Deane, and Yeovil unchanged.
- 19. A petition was received during the initial consultation period which suggested that the constituency of Yeovil should be renamed Yeovil and South Somerset. The assistant commissioners noted this constituency was unchanged, however considered that the alternative name would better reflect the main town of Yeovil in the constituency name and also the local authority (South Somerset) covered by the constituency.

- 20. Under both our initial and revised proposals we proposed no reduction in the number of constituencies in this sub-region. We recommend that the constituencies of Taunton Deane, and Yeovil and South Somerset retain their existing boundaries.
- 21. With the exception of the name change of the Yeovil and South Somerset constituency, the revised proposals for this sub-region were unchanged from the initial proposals.
- 22. There was general support for both our initial and revised proposals, with a respondent commenting that our proposals were logical with minimal disruption to the sub-region. However, we received opposition to the town of Frome remaining in its current constituency of Somerton and Frome. Residents of Frome asserted that they look to Bath, east Somerset and/or Wiltshire, not south towards Somerton. Representations noted that their geographical and cultural associations are with the neighbouring areas of Radstock, Midsomer Norton, Bath and also into West Wiltshire, Trowbridge and Warminster. Alternatively, it was suggested that Frome may be conjoined with its neighbouring Mendip District towns of Shepton Mallet, Wells and Glastonbury.
- 23. We also received a submission in opposition to the change of constituency name from Yeovil to Yeovil and South Somerset, contending that the name is tautological, as Yeovil is part of South Somerset and the largest town in that district. This representation requested that the current constituency name of Yeovil be retained.

Recommendations

24. Having considered the evidence and following discussions with the lead commissioner for this region, we recommend no changes to the boundaries of the revised proposals in this sub-region. In relation to the proposed name change of

the Yeovil and South Somerset constituency, on balance, taking into consideration the strength of evidence received during previous public consultations, we were not persuaded to modify the name for this constituency. We therefore recommend the constituency name Yeovil and South Somerset as part of the final recommendations. The counter-proposals received for the Bath and North East Somerset, and Somerset sub-region would not create an improved pattern of constituencies and no new and compelling evidence has been received to modify the revised proposals. We consider that no new or compelling evidence has been received that would persuade us to modify the Somerton and Frome constituency. The names and composition of each constituency for the final recommendations is detailed in appendix A.

Sub-region 2 - Bournemouth, Dorset, Poole, and Wiltshire

- 25. Of the 13 existing constituencies in this sub-region, only four have electorates that are currently within 5% of the electoral quota. The initial proposals allocated 12 constituencies to this sub-region and altered all of the 13 existing constituencies.
- 26. The initial proposals for the Bournemouth constituencies and Poole were near enough unanimously objected to; they were seen as far too disruptive to the current pattern of Parliamentary constituencies in Dorset. We received fervent opposition to the loss of the existing Bournemouth East constituency. Accordingly, the assistant commissioners reconfigured this area by leaving the existing Bournemouth East constituency unchanged and only made minor amendments to the proposed constituencies of Bournemouth West, Christchurch, Mid Dorset and Poole, bringing the electorates of each within the permitted range.

- 27. The revised proposals for Dorset were warmly welcomed, in particular both Bournemouth constituencies. Respondents approved of the minimum change approach taken to this area, in particular to the Bournemouth East constituency retaining its current boundary, and bringing together the Branksome East and Branksome West wards into a single constituency (Bournemouth West). Residents were pleased that the local community would remain connected to similar, nearby communities such as Littledown, Boscombe and Southbourne and the economic developmental needs of Bournemouth would be represented by only two Members of Parliament. Furthermore, Bournemouth University remained within one constituency (Bournemouth West). A counter-proposal was put forward to change the name of this constituency to Bournemouth West and Bourne Valley to reflect the inclusion of three wards from Poole Borough in the proposed Bournemouth West constituency.
- 28. Limited opposition was received in relation to the town of Verwood being divided between the proposed Mid Dorset, and Christchurch constituencies. A counter-proposal requested that the whole of Verwood be included in the Christchurch constituency which resulted in both constituencies falling outside of the permitted electoral range.
- 29. We received support for the revised West Wiltshire and North Wiltshire constituencies, especially around Chippenham. Our proposals for Corsham also received support as it unified the town of Corsham (which was divided under the initial proposals). Many residents were pleased that the towns of Corsham, Melksham and Trowbridge were included within a single constituency. Objections were received from the parishioners of Box Parish as the revised boundary divided the Box Hill and Rudlow area (in the West Wiltshire constituency) from the rest of the parish located in the North Wiltshire constituency. The parish spans across two wards, Box and Colnern, and Corsham Without and Box Hill, as a consequence of a relatively recent local boundary re-warding. Bringing the two wards together into one constituency would have resulted in knock-on effects across Wiltshire.

30. The constituency names of West Wiltshire and North Wiltshire were supported, although we also received some suggestions for alternative names. Some representations suggested the constituency name North Wiltshire be renamed Chippenham and North Wiltshire, and also suggested the constituency of West Wiltshire be renamed Trowbridge and West Wiltshire. In both cases respondents considered these names better reflected the main towns and geographic nature of these constituencies. In relation to the constituency of Devizes, we received a name change proposal to rename this constituency East Wiltshire. Having considered the names for constituencies in Wiltshire we consider that the name Devizes and East Wiltshire would be more appropriate for this constituency.

Recommendations

- 31. Having considered the evidence and following discussions with the lead commissioner for this region, we recommend no changes to the boundaries of the constituencies in this sub-region. It is considered that no new or compelling evidence has been received that persuades us to modify the pattern of constituencies in this sub-region.
- 32. However, we do recommended modifications to the constituency names. We recommend that the North Wiltshire, West Wiltshire and Devizes constituencies be renamed Chippenham and North Wiltshire, Trowbridge and West Wiltshire, and Devizes and East Wiltshire, respectively. We consider that these names reflect the conurbations in the constituency and the geographical area of the local authority. The names and composition of each constituency for the final recommendations is detailed in appendix A.

Sub-region 3 - Bristol

- 33. The City of Bristol currently has four constituencies. The Bristol South and Bristol North West constituencies are both within 5% of the electoral quota. The Bristol West constituency is above the permitted electoral range and the Bristol East constituency is below the permitted electoral range. The initial proposals retained the Bristol South and Bristol North West constituencies unchanged, and transferred the Easton ward from Bristol West to Bristol East to bring both constituencies within the permitted electoral range.
- 34. There were no major issues that drew objection in this sub-region during our consultation on the revised proposals. We received a counter-proposal which sought to avoid the Easton and Lawrence Hill wards being included in different constituencies. The respondent noted the areas distinctive shared community, identity and character with the other local communities in these wards such as Russell Town, Barton Hill and St Jude's. We received similar concerns during previous consultation which were considered by the Commission. The Bristol sub-region was generally supported during previous consultations.

Recommendations

35. Having considered the evidence and following discussions with the lead commissioner for this region, we consider that no new or compelling evidence has been received. Accordingly, we recommend no changes to the boundaries or constituency names of the revised proposals in the Bristol sub-region. The names and composition of each constituency for the final recommendations is detailed in appendix A.

Sub-region 4 - Cornwall, Devon, Isles of Scilly, Plymouth and Torbay

- 36. Of the existing 18 constituencies in this sub-region, only seven have electorates within the permitted electoral range. The initial proposals allocated 17 constituencies to this sub-region and retained the existing constituencies of Exeter, North Devon, and Torbay.
- 37. The initial proposals in the south and east of Devon proposed minimum changes to the existing constituencies to bring them within the electoral quota. A Bideford, Bude and Launceston constituency was proposed which included 18 wards from the District of Torridge in Devon, and nine wards from Cornwall. Consequently, changes were proposed to the other constituencies in Cornwall, combining areas of the north and south coast in constituencies, rather than constituencies running east to west along the coastline.
- 38. Some respondents strongly supported the initial proposals for both the Exeter and East Devon constituencies, content with the minimum change option. Conversely, some submissions proposed that the City of Exeter ward of St. Loyes ward should be included in the Exeter constituency. The assistant commissioners visited this area to test evidence received during the public consultations. Due to the strength of evidence, the assistant commissioners recommended the inclusion of the St. Loyes ward in the Exeter constituency as part of their revised proposals. However, the assistant commissioners noted that the argument was finley balanced between respecting the existing boundaries.
- 39. The revised proposals also swapped the St. Columb Major, and St. Stephen-In-Brannel wards between constituencies (Truro and Newquay, and Bodmin and St Austell respectively), thereby respecting the community ties these two wards have with their neighbouring areas, in particular uniting as much of the 'China Clay District' within a single constituency as possible within the statutory rules. The constituency names for the Plymouth area were changed to Plymouth Moor

View, and Plymouth Sutton and Devonport, reverting back to the original constituency names. The constituency name for Tavistock and Ivybridge was changed to Plympton, Tavistock and Ivybridge to better represent the identity of the electorate, and Falmouth and Camborne was changed to Falmouth, Camborne and Redruth to recognise the three largest towns in the constituency.

- 40. In response to the consultation on the revised proposals we received further passionate argument against the cross-county constituency of Bideford, Bude and Launceston. Many of the representations requested that the Commission treat Cornwall as a separate sub-region, contending that the unique needs of the Cornish electorate would not be adequately served by a cross-county Member of Parliament. However, as commissioners are aware, classifying Cornwall as a separate entity would result in at least one constituency with an electorate outside of the 5% threshold and is therefore not legally permissible. The Commission received no viable counter-proposals suggesting an alternative crossing of the river Tamar.
- 41. In relation to the Exeter, and East Devon constituencies, we received a mix of opposition and support for the revised proposals. Opponents considered the transfer of St. Loyes ward as unnecessary and unjustified. Future housing was a consideration when considering the configuration of the revised proposals; respondents made the point that future housing growth could also be used to argue for the St. Loyes ward to remain in its current constituency of East Devon. As a consequence of expected housing growth in both Exeter and East Devon, the feeling was that St. Loyes ward will be used like game of political 'ping pong' having to move this ward at each review. Concern was also raised with respect to the Topsham Ward becoming an orphan ward. We received a counter-proposal which included the St. Loyes ward being placed back into the East Devon constituency, as per the Commission's initial proposals. The result of this proposal would be that it would minimise disruption to the electors within these constituencies, Exeter would be an unchanged constituency and the Topsham ward would not be an orphan ward.

Recommendations

- 42. Having considered the evidence and following discussions with the lead commissioner for this region, we recommend that the St. Loyes ward is retained in the East Devon constituency, as per the existing arrangement and the Commission's initial proposals. This amendment would address concerns regarding unnecessary change to existing communities and avoid the Topsham ward becoming an orphan ward. Minimal change in this area would result in the Exeter constituency retaining its existing boundary.
- 43. We noted the strength of opposition to the Bideford, Bude and Launceston constituency; however, it is not possible to create a sub-region for Cornwall alone. We consider that no new or compelling evidence has been received to modify this proposed cross-county constituency that would address the local concerns and at the same time reflect the statutory criteria. We recommend no changes to the boundaries or constituency names of the revised proposals in relation to the constituencies in the Cornwall, Isles of Scilly, Plymouth and Torbay areas. The names and composition of each constituency for the final recommendations is detailed in appendix A.

Sub-region 5 - Gloucestershire, and South Gloucestershire

44. Of the nine existing constituencies in this sub-region, only three have electorates currently within the permitted electoral range. Under the initial proposals we proposed no reduction in the number of constituencies; however, we altered all nine constituencies. We received ardent submissions against many of our proposals in this sub-region during the first two consultation periods, and we therefore investigated alternative configurations for the constituencies in Gloucestershire and South Gloucestershire for our revised proposals.

- 45. In the north of this sub-region, the proposed constituency name of West Gloucestershire was unpopular. Accordingly, our revised proposals changed this constituency name back to its current name of Forest of Dean.
- 46. We noted the strong opposition to including the Springbank ward in a Tewkesbury constituency (including a petition of 192 signatures). Having considered the evidence, we modified our proposal in the Cheltenham constituency by placing the Springbank ward back into Cheltenham thereby satisfying the objections within Springbank ward and returning Cheltenham to an unchanged constituency.
- 47. As a consequence of reverting to the existing constituency for Cheltenham, modifications were required to the Tewkesbury constituency as part of the revised proposals. Assistant commissioners recommended that the Coombe Hill ward (currently in the Tewkesbury constituency) be divided between constituencies in order for the Tewkesbury constituency to be contiguous. The ELH and UCK polling districts were included in the Tewkesbury constituency providing for access from one end of the constituency to the other via the M5 motorway. The remaining polling districts in the Coombe Hill ward were included in the Forest of Dean constituency. We also proposed further changes to the Tewkesbury constituency, and to the south, the Gloucester City ward of Elmbridge was included in the Tewkesbury constituency along with the City ward of Longlevens to bring the Tewkesbury would be divided between three constituencies. However, we considered this necessary to achieve the best solution overall for the sub-region, whilst reflecting the evidence received during the consultation.
- 48. As Elmbridge ward had been transferred from the Gloucester constituency to the Tewkesbury constituency, we were able to return the Gloucester city wards of Quedgeley Fieldcourt and Quedgeley Severn Vale to the Gloucester

constituency. These changes allowed for the inclusion of the three Stroud district wards of Berkeley, Minchinhampton and Nailsworth into the Stroud constituency, resulting in the District of Stroud being divided between two constituencies under the revised proposals

- 49. In response to the recent consultation, our revised proposal to split the Coombe Hill ward between the constituencies of Tewkesbury and the Forest of Dean did not attract any significant support or objection. We received a couple of counter-proposals suggesting an alternative solution to splitting this ward; however, we considered these not to be viable. The first counter-proposal resulted in consequential knock-on effects leaving The Cotswolds, Forest of Dean, and Gloucester constituencies outside of the permitted electoral range. The second counter-proposal resulted in the Tewkesbury, and Gloucester constituencies falling outside of the permitted electoral range, as well as leaving the Elmbridge ward detached from its proposed constituency.
- 50. Many respondents objected to the City of Gloucester wards of Elmbridge and Longlevens being included in the Tewkesbury constituency. Residents of these wards asserted that they identified with Gloucester not with Tewkesbury, stating that the distance from these wards to Gloucester city would be much closer than that of the centre of Tewkesbury. The alternative to this proposals would result in the Quedgeley wards not being included in the Gloucester constituency and would require consequential changes to most of the revised proposals in the sub-region.
- 51. Turning to South Gloucestershire, the proposed Dursley, Thornbury and Yate constituency continued to attract opposition and we received many counter-proposals for this area. The current electorate of the local authority of Stroud was too small for two constituencies and too large for one constituency. Therefore, under our initial proposals, five Stroud district wards, including the towns of Cam and Dursley, and two wards from The Cotswolds (Kingswood, and Wotton-under-Edge) were included in the proposed Dursley, Thornbury and Yate constituency. Due to the knock-on

effects from transferring the Quedgeley wards back to the Gloucester constituency as part of our revised proposals, we were subsequently able to transfer both Berkeley, and Nailsworth wards back into their current constituency of Stroud and also allocate Minchinhampton ward to Stroud. We did not propose any changes to the initial proposals for the South Gloucestershire constituencies of Kingswood, and Filton and Bradley Stoke.

- 52. During all of the public consultation periods, respondents objected to the towns of Cam and Dursley being included in the Dursley, Thornbury and Yate constituency, contending that these proposals broke close ties with the town of Stroud and with the neighbouring Coaley and Uley ward currently in the Stroud constituency. These representations supported the towns of Cam and Dursley being included in a constituency with the town of Stroud, emphasising the historical connection between Stroud and other market towns in the vicinity, especially Nailsworth, Stonehouse, Dursley and Cam and the rural communities that link them. The alternatives to the revised proposals would require significant changes to nearly all constituencies across the sub-region.
- 53. The revised proposals also attracted objection to the Kingswood Parish being included in a Dursley, Thornbury and Yate constituency and suggested alternatively being transferred to either the Stroud or The Cotswolds constituencies. Placing the Kingswood ward in the Stroud constituency would result in this ward being detached from its constituency. Including this ward in The Cotswolds constituency may result in dividing the community of Kingswood and/or any community ties between the Kingswood ward and Wotton-Under-Edge ward.
- 54. Both Berkeley and Nailsworth wards were retained in their current constituency of Stroud under the revised proposals and received support. The inclusion of the ward of Minchinhampton into the Stroud constituency received more support than opposition with residents welcoming this arrangement due to its geographical proximity to Stroud and its shared

identity - historically, culturally, and socially.

Recommendations

- 55. As will be outlined in the presentation to commissioners, having considered the evidence and following discussions with the lead commissioner for this region, we recommend no changes to the boundaries or constituency names of the revised proposals in this sub-region.
- 56. We consider that splitting the Coombe Hill ward between the Forest of Dean and Tewkesbury constituencies created a constituency that is continuous from one end to the other, with the M5 motorway providing road access. This also reflected the evidence that the Springbank ward should be included in the Cheltenham constituency, resulting in the Cheltenham constituency retaining its current boundary. Retaining the Quedgeley wards within the Gloucester constituency, and including the Elmbridge ward in the Tewkesbury constituency caused minimal disruption to electors in this area. We have sympathy with residents from the towns of Cam and Dursley, however, due to the constraints of keeping within the electoral quota and the consequential knock-on effects that would be caused by transferring Cam and Dursley to the Stroud constituency, we recommend no change to the configuration of the Stroud, and Dursley, Thornbury and Yate constituencies. The names and composition of each constituency for the final recommendations is detailed in appendix A.

Sub-region 6 - North Somerset

57. There are currently two constituencies within this sub-region, which covers the unitary authority of North Somerset, and Weston-super-Mare, both of which have electorates within the permitted electoral range. We did not consider it

necessary to propose any change to these constituency boundaries. We received general support for our initial proposals, however we also received a small number of submissions in opposition. A respondent viewed the North Somerset constituency as a collection of disparate small towns and villages and suggested an alternative cross-river constituency with Bristol. In light of representations received, the revised proposals for North Somerset were the same as the initial proposals.

58. In response to the consultation on our revised proposals there were no major issues that drew objections in this sub-region.

Recommendations

- 59. We recommend that the Commission consider the composition of the constituency name of Weston-super-Mare for consistency. The Parliamentary Constituencies (England) Order 2007 stipulates the spelling of this constituency with a capital 'S', however the Commission's initial and revised proposals have published the name with a lowercase 's' which reflects the spelling of the local government wards and Town Council.
- 60. As will be outlined in the presentation to commissioners, having considered the evidence and following discussions with the lead commissioner for this region we recommend no changes to the constituency boundaries of the revised proposals in this sub-region. The names and composition of each constituency for the final recommendations is detailed in appendix A.

Sub-region 7 - Swindon

- 61. There are currently two constituencies in this sub-region, North Swindon, and South Swindon, encompassing the unitary authority of Swindon. Only the North Swindon constituency had an electorate within 5% of the electoral quota. We were unable to leave this constituency unchanged due to changes being required to the Swindon South constituency.
- 62. Two wards in Swindon borough are currently divided between the existing North Swindon, and South Swindon constituencies following changes to local government wards in the borough. The majority of both wards are in the North Swindon constituency. We noted that to include the divided Mannington and Western ward entirely in Swindon North would isolate the two wards of the Lydiard and Freshbrook, and Shaw from the remainder of the South Swindon constituency. Therefore, as part of our initial proposals we included the Mannington and Western ward in the South Swindon constituency and the whole of the Covingham and Dorcan ward in the North Swindon constituency. This resulted in both the South Swindon, and North Swindon constituencies having electorates within 5% of the electoral quota.
- 63. Our initial proposals for the Swindon constituencies were largely supported with respondents citing that they were pleased with the minimal disruption to community ties, therefore we retained these boundaries as part of the revised recommendations.
- 64. The Commision received limited comment in response to the consultation on our revised proposals. We received one counter-proposal suggesting that the current boundary for South Swindon, and North Swindon should be followed in the west, and the communities of Nythe and Covingham along the Parish Council boundaries should be included in the South Swindon constituency.

Recommendations

65. As will be outlined in the presentation to commissioners, having considered the evidence and following discussions with the lead commissioner for Swindon, we recommend no changes to the boundaries or constituency names of the revised proposals in this sub-region. Having considered the evidence we have investigated the counter-proposals received and do not consider they necessarily improve community ties within a constituency. The names and composition of each constituency for the final recommendations is detailed in appendix A.
