Initial/revised proposals overview

1. Yorkshire and the Humber was allocated 50 constituencies under the initial and revised proposals, a reduction of four from the existing allocation. In our initial proposals we proposed two sub-regions. Humberside formed a sub-region and the combined area of North Yorkshire, South Yorkshire, and West Yorkshire formed another sub-region. In the revised proposals, we proposed that Humberside and North Yorkshire form two separate sub-regions, with the combined area of South Yorkshire and West Yorkshire forming a third sub-region. In formulating the initial and revised proposals the Commission therefore decided to construct constituencies using the following sub-regions:

2. Under the initial proposals three of the existing 54 constituencies were completely unchanged. The revised proposals retained eight of the existing constituencies unchanged. Under the initial proposals it was proposed to have four constituencies that crossed county boundaries - two between North Yorkshire and West Yorkshire, and two between South Yorkshire and West Yorkshire. In the revised proposals it was proposed to have two constituencies that crossed county boundaries - both between South Yorkshire and West Yorkshire. In Humberside it was possible to allocate a whole number of constituencies to the county. In North Yorkshire, as we treated the county as a separate sub-region in the revised proposals, it was also possible to allocate a whole number of constituencies to the county.
3. In response to the consultation on the initial proposals and secondary consultation the Commission received almost 2,000 representations regarding Yorkshire and the Humber. These representations commented on most parts of the region, with the main issues being:
 - The proposed constituencies of Grimsby North and Barton, and Grimsby South and Cleethorpes. Grimsby respondents objected to these constituencies and the perceived division of the town of Grimsby.
 - The proposed constituencies covering Kingston upon Hull. A number of alternative counter-proposals for the three Kingston upon Hill constituencies were submitted.
 - The proposed Richmond (Yorks) and Thirsk and Malton constituencies. There was strong objection to the inclusion of the Great Ayton ward in the Thirsk and Malton constituency.
 - The proposed Selby and Ainsty constituency. Respondents objected to the inclusion of the two District of Selby wards of Byram & Brotherton, and Whitley in two cross-county boundary constituencies, but in particular, the consequential inclusion of the two Borough of Harrogate wards of Boroughbridge and Claro in Selby and Ainsty.
 - The proposed constituencies in the City of Sheffield, the consequent effects in the county of not splitting wards in the City, and in particular, the exclusion of the Mosborough and Beighton wards from a Sheffield constituency.

- The division of the Borough of Barnsley across six constituencies
 - The proposed constituencies in the Borough of Doncaster
 - The proposed cross-county boundary constituency of Colne Valley and, in particular, the inclusion of the Borough of Barnsley ward of Penistone West in the constituency.
 - The proposed 'loss' of the Bradford South constituency and the allocation of wards to surrounding constituencies, particularly the Wibsey, Wyke, Royds and Tong wards.
 - To the proposed constituencies in the Borough of Calderdale: Halifax and Calder Valley.
4. In considering the evidence received, the Commission altered 68% of the constituencies in Yorkshire and the Humber; three of these constituencies were subject only to a change of name.

Number of representations received

5. In Yorkshire and the Humber, the Commission received a total of 1,076 representations during consultation on the revised proposals, bringing the total number of representations for this region to 3,059. This number included all those who gave evidence at the public hearings. There were also a number of duplicate representations within this total, as well as representations that made general comments that did not have any bearing on the substance of the initial proposals.

6. While many of the representations can be categorised as opposing the Commission's revised proposals, there has been a degree of support for certain constituencies across the whole region. These include, but are not limited to, the constituencies of Bradford South, Harrogate and Knaresborough, Richmond (Yorks), Lower Calder, Upper Calder, and various constituencies in Leeds and Sheffield.

Campaigns

7. As expected, throughout the region, representations from a number of organised campaigns were received. In Yorkshire and the Humber, these were as follows:-

8. During the previous consultations the Commission received five campaigns in relation to Yorkshire and the Humber. None of these campaigns were put forward again during the consultation on the revised proposals, although the Great Grimsby Constituency campaign (BCE-51951) is similar to the Great Grimsby 2Gether campaign (BCE-33230).

Major issues

9. Major issues that drew objection were as follows:-

Humberside

- The continued division of the town of Grimsby with further requests for the splitting of the Croft Baker ward
- The inclusion of the Derringham ward in the Kingston upon Hull North constituency.

North Yorkshire

- The continued inclusion of the Filey ward in the Thirsk and Malton constituency rather than in the Scarborough and Whitby constituency, as in the initial proposals.

South Yorkshire and West Yorkshire

- The inclusion of the Dearne South and Dearne North wards in different constituencies and, in particular, the inclusion of Dearne South in Doncaster North
- The division of the Metropolitan Borough of Barnsley between constituencies
- The inclusion of the Penistone West ward in the cross-county constituency of Colne Valley
- The inclusion of the Hemsworth ward in the cross-county constituency of Barnsley East and Hemsworth
- The inclusion of the Bingley Rural ward in the Bradford North constituency, instead of the Shipley constituency
- The inclusion of the Guiseley and Rawdon ward in the Shipley constituency, rather than in a Leeds-based constituency

Final recommendations

10. In light of the representations and evidence received we have considered whether the revised proposals should be changed.

11. The final recommendations have been formulated on the same sub-regions used as the revised proposals. North Yorkshire was treated as a sub-region on its own in the revised proposals, whereas it had been included in a sub-region with South Yorkshire and West Yorkshire in the initial proposals. No counter-proposals were received during the consultation on the revised proposals which suggested alternative sub-regions, although a very small number of representations suggested crossing the regional boundary with the East Midlands region in order to create a different pattern of constituencies in the Cleethorpes and Grimsby area.

12. Under the final recommendations eight of the existing constituencies are unchanged. In the initial proposals four constituencies were proposed that crossed county boundaries; in the revised proposals, two constituencies were proposed to cross county boundaries. The final recommendations would continue to have two constituencies crossing county boundaries.

Overview

13. In the initial proposals, we divided Yorkshire and the Humber into two sub-regions: Humberside; and North Yorkshire, South Yorkshire, and West Yorkshire. Although support was received for the creation of these sub-regions, there was also some objection in the initial and secondary consultation periods to the sub-regions. A number of alternatives were put forward suggesting that North Yorkshire should be considered as a sub-region in its own right. We considered that these alternatives did provide for a better pattern of constituencies and we amended our sub-regions in the revised proposals to Humberside; North Yorkshire; and South Yorkshire and West Yorkshire. We recommend no changes to the sub-regions as part of the final recommendations.

Sub-region 1 - Humberside

14. Of the ten existing constituencies in the former county of Humberside two, Beverley and Holderness, and East Yorkshire were within the permitted electorate range. The remaining eight constituencies have electorates that are below the permitted electorate range. The initial and revised proposals were for nine constituencies, and the two existing constituencies mentioned above remained unchanged. The main issue in the initial proposals was the division of the town of Grimsby between constituencies. It was acknowledged by some respondents that, without the splitting of wards, there were realistically only two possible solutions for the constituencies covering Grimsby and Cleethorpes.
15. The revised proposals in this sub-region amended the composition of three constituencies we proposed as part of the initial proposals (Kingston upon Hull East, Kingston upon Hull North, and Kingston upon Hull West and Haltemprice). Two constituency names were changed in the revised proposals (Great Grimsby North and Barton, and Great Grimsby South and Cleethorpes). Objections to the Kingston upon Hull constituencies had led to a variety of alternative

compositions for the constituencies in the city being suggested. We decided to adopt one of these counter-proposals, which retained the existing Kingston upon Hull East constituency, plus the Myton ward, the existing Kingston upon Hull North constituency, plus the Derringham ward, with the remainder of the Kingston upon Hull wards being included with five District of East Riding wards in the revised Kingston upon Hull West and Haltemprice constituency.

16. The revised proposals in Humberside have been supported and opposed by respondents during the recent consultation. Some respondents have called for the reinstatement of the initial proposals for the Kingston upon Hull constituencies. There continued to be significant opposition to the proposed Great Grimsby North and Barton, and Great Grimsby South and Cleethorpes constituencies, with almost all of the objection concerning the perceived breaking of community ties within Grimsby. As in the initial proposals consultation, it was suggested that the Croft Baker ward should be divided. However, we we received no significant new evidence supporting this proposal.
17. There was support for the change of name of the Goole and Axholme constituency, although there were calls for us to go further and include Haltemprice or Howdenshire in the constituency name, as much of the constituency would contain wards from the existing Haltemprice and Howden constituency. The remainder of the constituencies in Humberside elicited few representations.

Recommendations

18. Having considered the evidence and following discussions with the lead commissioner for this region, we recommend no changes to the boundaries of the revised proposals in this sub-region. In Kingston upon Hull we consider that no new or compelling evidence has been received that persuades us to modify the Kingston upon Hull constituencies, which closely resemble the existing pattern of constituencies in the city.

19. With regard to the proposed Great Grimsby South and Cleethorpes, and in particular, the Great Grimsby North and Barton constituencies, we did not consider that the evidence received provides for an exceptional and compelling case to divide a ward in this part of the sub-region, nor that any new evidence was presented that would persuade us to alter the composition of these constituencies. However, we were persuaded by the representations that suggested that the Great Grimsby North and Cleethorpes constituency should be renamed Cleethorpes and Great Grimsby South, to reflect that the town of Cleethorpes and its surrounding areas formed the larger part of the constituency. We were also persuaded by the representations that suggested that Howdenshire or Haltemprice should be included in the Goole and Axholme constituency name, and decided to rename the constituency Goole, Howdenshire and Axholme. The names and composition of each constituency for the final recommendations is detailed in appendix A.

Sub-region 2 - North Yorkshire

20. There are eight existing constituencies in North Yorkshire (including the City of York) of which seven are within the permitted electorate range and could be retained in the initial proposals. In the initial proposals we decided to make no change to the York Central and York Outer constituencies, other than to realign the constituency boundaries with revised ward boundaries. However, the electoral size and shape of wards in West Yorkshire would make it very difficult to create constituencies that were within the permitted range without dividing towns or wards between constituencies. We therefore proposed to combine North Yorkshire with West Yorkshire in order to give us more flexibility when constructing constituencies. With this aim in mind, we also decided to include South Yorkshire to form a sub-group of the three counties.

21. In the initial proposals we constructed two constituencies that crossed the county boundary between North Yorkshire and West Yorkshire, with the inclusion of the District of Selby wards of Byram & Brotherton in the proposed Normanton, Castleford and Outwood constituency, and Whitley in the proposed Pontefract constituency. To compensate for the exclusion of these two wards from the Selby and Ainsty constituency, we included in it the Borough of Harrogate wards of Boroughbridge and Claro, and to further compensate for the exclusion of these two wards from the Harrogate and Knaresborough constituency, we included the ward of Washburn in this constituency from the existing Skipton and Ripon constituency. In order to bring the electorate of the existing Scarborough and Whitby constituency within the permitted electorate range, we included in the constituency the Borough of Scarborough ward of Filey from the Thirsk and Malton constituency, and to compensate for this change, included the Great Ayton ward in Thirsk and Malton from the existing Richmond (Yorks) constituency.
22. In the initial and secondary consultation periods, there was little support for our proposals. A number of representations called for North Yorkshire to be treated as a sub-region on its own. There was objection to the two District of Selby and Ainsty wards being included in two cross-county boundary constituencies and, in particular, significant opposition to the consequent moves to compensate for this transfer with the inclusion of the Boroughbridge and Claro wards in Selby and Ainsty. There was also very vocal and significant opposition to the inclusion of the Great Ayton ward in the Thirsk and Malton constituency. In the revised proposals, we treated North Yorkshire on its own and included the Byram & Brotherton, and Whitley wards in the Selby and Ainsty constituency. This allowed us to 'return' the Boroughbridge and Claro wards to the Harrogate and Knaresborough constituency, and the Washburn ward to the Skipton and Ripon constituency.
23. We were persuaded by the strong evidence that the Great Ayton ward looked almost exclusively to Richmond (Yorks) and that the ward was separated from the rest of the Thirsk and Malton constituency by the North Yorks moors. In the

revised proposals we therefore included the Great Ayton ward in the Richmond (Yorks) constituency. To now bring the Thirsk and Malton constituency within the permitted electorate range, we ‘returned’ the Filey ward to the constituency, although the assistant commissioners had considered that the ward’s inclusion in Scarborough and Whitby was logical. To bring the Scarborough and Whitby constituency within the permitted electorate range, we included the District of Ryedale ward of Thornton Dale in the Scarborough and Whitby constituency, noting the good links with the ward to Scarborough along the A170.

24. The revised proposals resulted in three constituencies being completely unchanged from the existing constituencies, three being changed only due to rewording, and two constituencies that were changed only by one ward.
25. The revised proposals have been largely supported during the recent consultation: there was support for our decision to treat North Yorkshire as a sub-region and, in particular, for the revised proposals for the Selby and Ainsty, Harrogate and Knaresborough, and Richmond (Yorks) constituencies. Although we received little by way of comment concerning the inclusion of the Filey ward in the Scarborough and Whitby constituency in the initial proposals, there was some objection to the ward being transferred back to the Thirsk and Malton constituency in the revised proposals.

Recommendations

26. Having considered the evidence and following discussions with the lead commissioner for this region, we recommend no changes to the boundaries of the revised proposals in this sub-region. With regard to the inclusion of the Filey ward in either the Scarborough and Whitby, or Thirsk and Malton constituencies, we considered that the opposition to the revised proposals was to an existing arrangement and we did not consider that there were sufficient grounds to include Filey in the Scarborough and Whitby constituency. The consequent inclusion of both the Thornton Dale and Derwent

Valley wards in Thirsk and Malton was rejected, particularly since we had not moved the Derwent Valley ward in either the initial or revised proposals, which meant that this element had not been tested in a public consultation.

27. The names and composition of each constituency for the final recommendations is detailed in appendix A.

Sub-region 3 - South Yorkshire and West Yorkshire

28. There are currently 22 constituencies in the metropolitan county of West Yorkshire (the Boroughs of Calderdale and Kirklees, and the Cities of Bradford, Leeds and Wakefield), and 14 existing constituencies in the metropolitan county of South Yorkshire (the Boroughs of Barnsley, Doncaster and Rotherham, and the City of Sheffield). In view of the large ward sizes in both South Yorkshire and West Yorkshire and the challenge we would have in constructing constituencies that did not divide communities, we initially decided to form a sub-group of these two counties with North Yorkshire and allocate 41 constituencies to the sub-group, a reduction of three. Following the consultations on the initial proposals we decided to treat North Yorkshire separately and to allocate 33 constituencies to the combined sub-region of South Yorkshire and West Yorkshire, a reduction of three.
29. Of the 36 existing constituencies in the sub-region, nine have electorates that are within the permitted electorate range. Of the remaining 27 constituencies, just one (Colne Valley) has an electorate that is above the permitted electorate range; all the rest have electorates below.

West Yorkshire

30. Of the existing 22 constituencies in West Yorkshire, seven are within the permitted electorate range. In the initial proposals we retained just one constituency wholly unchanged (Elmet and Rothwell). The Dewsbury constituency was altered only to realign with ward boundaries following local government boundary changes.
31. It was necessary to reduce the number of constituencies in West Yorkshire by two - one from the City of Leeds, and one from the City of Bradford. In the initial proposals we had made relatively modest changes to the constituencies in the City of Leeds with a limited exchange of wards between constituencies to bring them all within the permitted electorate range. We included the Headingley ward in the Leeds North East constituency instead of in Leeds North West, and to compensate for this transfer included in Leeds North West the wards of Kirkstall and Horsforth. The proposed Pudsey constituency included the City of Bradford ward of Tong. The Batley and Morley constituency included two wards from the Borough of Kirklees (Batley East and Batley West) and three wards from the City of Leeds.
32. We proposed significant changes to the existing Morley and Outwood, and Normanton, Pontefract and Castleford constituencies, and we received some objection to the two constituencies that crossed the county boundary with North Yorkshire (the Normanton, Castleford and Outwood, and Pontefract constituencies), although most of the objection had come from North Yorkshire. The proposed Wakefield constituency was the same as the existing constituency, apart from the inclusion of the Wakefield South ward. The proposed Barnsley East and Hemsworth constituency included two City of Wakefield wards of Hemsworth, and Crofton, Ryhill and Walton.
33. It had not been possible to construct two constituencies that were wholly composed of Borough of Calderdale wards, and although we constructed a Calder Valley constituency which did include only Borough of Calderdale wards, we

included the City of Bradford ward of Royds in the proposed Halifax constituency. The proposed Keighley constituency was unchanged apart from the inclusion of the City of Bradford ward of Wharfedale. In Kirklees, the Huddersfield constituency included the Lindley ward to bring it within the permitted electorate range, and the Colne Valley constituency included the Borough of Barnsley ward of Penistone West.

34. In reducing the number of constituencies in West Yorkshire the initial proposals for Bradford no longer included a Bradford South constituency. As mentioned above, we included the City of Bradford wards of Tong in the proposed Pudsey constituency, Wibsey and Wyke in the Spen constituency, Royds in the Halifax constituency, and Great Horton and Queensbury in the Bradford West constituency. The Bradford West constituency was otherwise unchanged apart from these inclusions and the exclusion of the Manningham ward, which we included in the Bradford East constituency, which itself was otherwise unchanged, apart from the inclusion of this ward.
35. In response to the consultation on the initial proposals there was a general degree of support for the proposed constituencies in the City of Leeds, although there were objections to the inclusion of the Headingley ward in the Leeds North East constituency and, in particular, the inclusion of the Guiseley and Rawdon ward in the Shipley constituency, which, it was argued, divided the community of Yeadon. This ward has the largest electorate of any ward in Yorkshire and the Humber, and its shape does mean that part of the ward is in something of a spur that juts into the Leeds North West constituency. However, the Shipley constituency needed to be brought within the permitted electorate range and the assistant commissioners were not persuaded that there was sufficient reason to split this ward. We made no changes to the Leeds constituencies in the revised proposals, apart from the Pudsey constituency.
36. Following the initial proposals consultation and our subsequent decision in the revised proposals not to cross the county boundary between North Yorkshire and West Yorkshire, the revised Normanton, Pontefract and Castleford constituency

was now unchanged from the existing constituency. We accepted the counter-proposal that suggested the construction of a Featherstone constituency and the inclusion of the towns of Ossett and Outwood in the Wakefield constituency, although the initial proposals had only made minor change to the Wakefield constituency. Apart from the Hemsworth ward, all the City of Wakefield wards would now be contained within the three constituencies in the Wakefield local authority area. There was some support for the revised proposals which recreated the existing Normanton, Pontefract and Castleford constituency, although there was some objection to the revised Wakefield constituency.

37. The initial proposals in the Borough of Calderdale were generally not supported and attracted counter-proposals and a campaign against the proposed pattern. We consequently revised the Halifax and Calder Valley constituencies, accepting a counter-proposal for Lower Calder and Upper Calder constituencies. This was widely welcomed in the consultation on the revised proposals. There had been relatively little comment on the Dewsbury, Huddersfield, Batley and Morley, and Keighley constituencies in any of the representation periods and we decided not to revise these constituencies, although there was some support for a counter-proposal for the Keighley and Shipley constituencies. As during the initial proposals, there continued to be objections to the cross-county constituency of Colne Valley with it being argued that this divided the community of Penistone and that this South Yorkshire ward had little in common with the rest of the Colne Valley constituency, although no significant new evidence was submitted during the revised proposals consultation.
38. We received very substantial opposition, including a number of campaigns, and scant support for constituencies in the City of Bradford. We received numerous counter-proposals, many of which suggested the splitting of a number of wards. Most of the representations were opposed to the perceived 'loss' of the Bradford South constituency, and there were particular objections to the inclusion of City of Bradford wards in surrounding constituencies. Many respondents felt that the Tong, Wibsey, Wyke, Royds, Great Horton, and Little Horton wards should be in the same constituency.

39. The assistant commissioners did not consider that there were sufficient grounds to split any City of Bradford wards, however they did recognise that modification needed to be made to try to address the huge body of opposition towards the Bradford constituencies. They visited the Idle and Thackley, Eccleshill, Bradford Moor, Wibsey and Wyke wards to observe for themselves the ties 'on the ground'. It would not be possible to address all the concerns raised, but they recommended a new Bradford South constituency, which would contain the wards of Clayton and Fairweather Green, Great Horton, City, Bowling and Barkerend, Little Horton, Wibsey and Royds. On the assistant commissioners' recommendation, the Tong and Wyke wards were included with Borough of Kirklees wards from the existing Spen constituency to construct a Bradford South East and Spen constituency (although they were mindful of the representations that suggested Bradford had little in common with Spen), noting that the two Bradford wards were effectively separated from the centre of Bradford by the A6036 and A6177 roads. The Bradford Moor ward, despite its proximity to the centre of Bradford, was considered the only suitable candidate among the wards of Idle and Thackley, and Eccleshill for inclusion in the Pudsey constituency. A New Bradford North constituency was created which included most of the remaining Bradford wards, including the Bingley Rural ward, and the Idle and Thackley ward was included in a revised Shipley constituency.
40. In response to our revised proposals, there was a strong degree of support for the proposals for the Lower Calder and Upper Calder constituencies, but it was suggested in representations that the name Lower Calder was a completely inaccurate description as the River Calder continued to run for many miles eastwards through the Kirklees and Wakefield districts, and that the constituency also included areas of high ground. It was also suggested that the Upper Calder name was inappropriate as it excluded reference to the sizable town of Halifax. It was brought to our attention that Halifax had appeared in a constituency name since 1832.

41. There was some objection to the revised proposals in the City of Wakefield local authority, particularly with regard the creation of the Featherstone constituency, the inclusion of the Wakefield South ward in this constituency rather than in Wakefield, and the inclusion of the Hemsworth ward in the cross-county boundary constituency of Barnsley East and Hemsworth, particularly from the Fitzwilliam and Kinsley areas in the north of the ward.
42. There was a general level of support for the proposed Bradford South constituency, although some representations asked us to go still further and divide wards and include all the wards that had been identified as being Bradford South constituency wards. There was little objection to the inclusion of the Bradford Moor ward in the Pudsey constituency, or of the Tong and Wyke wards in the Bradford South East and Spen constituency.
43. However, there was very considerable opposition to the inclusion of the Bingley Rural ward in the proposed Bradford North constituency. Such opposition accounted for approximately 40% of all the representations received for the whole of Yorkshire and the Humber to the revised proposals. It was submitted that the inclusion of the Bingley Rural ward in Bradford North instead of in Shipley broke ties with the Bingley ward, and many representations suggested that the ward should continue to be included in the Shipley constituency, and that the Idle and Thackley ward be transferred from the Shipley constituency to the Bradford North constituency. It was noted that the Idle and Thackley ward was currently located in the existing Bradford East constituency.

Recommendations

44. Having considered the evidence and following discussions with the lead commissioner for this part of the sub-region, and as there was a significant degree of support for the revised proposals throughout West Yorkshire, with mostly no

significant new evidence presented for the the constituencies that continued to be opposed, we recommend no changes to the boundaries of all but two of the revised constituencies in this part of the sub-region.

45. We considered that the representations that suggested changes to the names of the proposed Lower Calder and Upper Calder constituencies had made valid points. We therefore recommend amending the names, but not the composition, of the Upper Calder and Lower Calder constituencies, respectively, to Halifax and North Calderdale (Calderdale being the name of the local authority), and South Calderdale and Queensbury (to reflect that the constituency included the 'orphan' City of Bradford ward of Queensbury).
46. We propose that a more suitable name should be adopted for the Colne Valley constituency as it includes the 'orphan' Borough of Barnsley ward of Penistone West. Although the ward of Penistone East is included in the Barnsley West and Stocksbridge constituency, we accept the evidence that the town of Penistone is located entirely within the Penistone West ward and that the town's inclusion in the name of the Colne Valley constituency would be appropriate. We therefore propose a revision to the name of the Colne Valley constituency to Colne Valley and Penistone.
47. With regard to the opposition we received to the constituencies in the City of Wakefield, we considered that to make further changes to constituency boundaries would have detrimental knock-on effects throughout the rest of the region and could not be tested in any further consultation periods. However, we do not consider that the Featherstone constituency name is entirely appropriate and propose to revise the name to Wakefield South and Rural, variations of which had been suggested in representations, as a more accurate description of the constituency. The constituency is located entirely in the City of Wakefield local authority and includes both the Wakefield South and Wakefield Rural wards. We therefore recommend only this change to our revised constituencies in the city of Wakefield.

48. We considered the evidence with regard to the Bingley Rural ward to be compelling. It would be possible to include the Bingley Rural ward in the Shipley constituency, and the Idle and Thackley ward in the Bradford North constituency without any further knock-on effects on other constituencies, as both constituencies would remain within the permitted electorate range. This would also provide a better reflection of existing constituency boundaries. We therefore recommend modifying the proposals with regard the Bradford North and Shipley constituencies.
49. The names and composition of each constituency for the final recommendations is detailed in appendix A.

South Yorkshire

50. Of the 14 existing constituencies in South Yorkshire, two are within the permitted electorate range (Rother Valley, and Wentworth and Dearne). All the remaining constituencies have electorates that are below the permitted electorate range. In the initial proposals, all of the constituencies in South Yorkshire were changed.
51. As it was necessary to reduce by one the number of constituencies in South Yorkshire, in the initial proposals we redistributed the wards from the existing Penistone and Stocksbridge constituency across four constituencies and constructed a Sheffield Hallam and Stocksbridge constituency that included five City of Sheffield wards and the Borough of Barnsley ward of Penistone East. We made significant changes to the other Sheffield constituencies where we had decided not to split wards. The decision not to split wards had a knock-on effect throughout the county. We included the City of Sheffield wards of Mosborough and Beighton in the Rother Valley constituency, which did not need to be altered, the Borough of Rotherham wards of Brinsworth and Catcliffe, and Keppel, respectively, in the proposed Sheffield East and Sheffield North and Ecclesfield constituencies. The Wentworth and Dearne constituency, which was within the

permitted electorate range, was altered with the Borough of Barnsley wards of Dearne North and Dearne South being replaced in the constituency by the Borough of Barnsley wards of Hoyland Milton, and Rockingham.

52. In the Borough of Doncaster, we proposed that the Doncaster Central constituency be changed only by the inclusion of the divided ward of Stainforth & Barnby Dun. With regard to the other two constituencies in Doncaster, we proposed a different alignment of the constituencies, which subsequently led us to change the names of the existing Doncaster North and Don Valley constituencies to Doncaster East, and Doncaster West, the latter including the Barnsley borough ward of Dearne North from the existing Wentworth and Dearne constituency.
53. The Borough of Barnsley is currently divided across four constituencies; the initial proposals divided the borough across six constituencies. We included the two Borough of Barnsley wards of Dodworth and Worsbrough in the Barnsley Central constituency to bring it within the permitted electorate range, and we altered the existing Barnsley East constituency to cross the county boundary with West Yorkshire, including in the constituency the two City of Wakefield wards of Hemsworth, and Crofton, Ryhill and Walton. To recognise the inclusion of these wards in the constituency we named it Barnsley East and Hemsworth. The constituency would also include the Dearne South ward with the Dearne North ward, as mentioned previously, being included in Doncaster West. As also mentioned previously, the Borough of Barnsley ward of Penistone West was included in the cross-county boundary constituency of Colne Valley.
54. The initial proposals in Sheffield were widely opposed. Many of the counter-proposals suggested the splitting of wards - some half of the 28 wards in Sheffield were suggested as suitable candidates for splitting in the representations - with many of them suggesting the proposals had resulted in the breaking of ties in the City. There was particular opposition, and a campaign against, the exclusion of the Mosborough and Beighton wards from a Sheffield constituency. In view of the number of representations that had suggested the splitting of wards in Sheffield, and the evident domino effect of the

initial proposals throughout South Yorkshire, the assistant commissioners visited six wards in Sheffield that had been identified in two different counter-proposals as candidates for splitting. Following their observations, they recommended the adoption of the counter-proposal that split the Burngreave, Crookes and Central wards. This allowed for the return of the Mosborough and Beighton wards to a Sheffield constituency, the five Sheffield constituencies would be wholly contained within the Sheffield City boundary, and only the ward of Stocksbridge and Upper Don would not be included in a Sheffield constituency. We accepted their recommendations and revised the proposals for Sheffield, although they would be slightly different as we took into account the new ward boundaries that came into being for the 2016 local elections. The revised proposals for Sheffield meant that we are able to return the Rother Valley to the existing constituency configuration, and also Rotherham (apart from addition of the Wickersley ward).

55. In Doncaster, a well-supported counter-proposal was received that closely matched the existing pattern of constituencies in the borough. However, it suggested crossing the county boundary with West Yorkshire and included the City of Wakefield ward of South Elmsall and South Kirkby in the Doncaster North constituency. The assistant commissioners visited this ward and concluded that it should not feature in a Doncaster constituency. They also visited the two Barnsley borough wards of Dearne North and Dearne South. Although they noted the community ties between these two wards, and preferred not to include them in separate constituencies, they recommended the adoption of the counter-proposal with the additional inclusion of the Dearne South ward in the Doncaster North constituency, instead of the South Elmsall and South Kirkby ward, to avoid crossing the county boundary in this area.
56. The assistant commissioners had also visited the City of Wakefield ward of Hemsworth. It would still be necessary to cross the county boundary with West Yorkshire, and they concluded that Hemsworth's inclusion in a revised Barnsley East and Hemsworth constituency (which would also include the Dearne North ward) would allow for the creation of acceptable constituencies in the sub-region. The initial proposals for the constituency were therefore revised.

57. There had been opposition to the proposed constituencies in Barnsley, but the assistant commissioners considered that the electorates in South and West Yorkshire were such that there would have to be a considerable degree of disruption to the existing pattern of constituencies and that the solutions for Barnsley were to a large extent dependent on the revised proposals in Sheffield and Rotherham. On their recommendation the Barnsley Central constituency was reconfigured and named Barnsley West and Stocksbridge as it included the City of Sheffield ward of Stocksbridge and Upper Don. The constituency would also include the Penistone East ward. Despite the objection to the inclusion of the Penistone West ward in the cross-country boundary constituency of Colne Valley and the perceived separation of the two Penistone wards, we decided not to amend this constituency.
58. We made some modest alterations to the initial proposals for the Wentworth and Dearne constituency by additionally including the Borough of Barnsley ward of Wombwell in the constituency and returning the Wingfield ward to the Rotherham constituency, as in the existing arrangements. The revised recommendations for this area meant that the Borough of Barnsley was now divided across five constituencies, rather than six as in the initial proposals.
59. The revised proposals for South Yorkshire elicited relatively few comments. Although there was a counter-proposal that suggested we use a different configuration of split wards in Sheffield, the proposals in the City were generally not opposed and it was considered that the revised proposals were a considerable improvement on the initial proposals. The revised proposals for the Borough of Rotherham meant that the constituencies were either the same, or not too dissimilar to the existing pattern of constituencies, and we received few further representations that commented on Rotherham. Similarly, few comments were received with regard to the three Borough of Doncaster constituencies, although there was a considerable degree of opposition to the separation of the two Dearne wards and the inclusion of

the Dearne South ward in Doncaster North. The assistant commissioners had proposed this inclusion following their visit to this area and considered that it allowed for a more suitable pattern of constituencies in the area as a whole.

60. The revised proposals for the Borough of Barnsley also resulted in few comments, although the view continued to be voiced that Barnsley had been unfairly treated with the Borough being divided across five constituencies. There continued to be opposition to the inclusion of the Penistone West ward in the Colne Valley constituency, but we considered that no new evidence was submitted.

Recommendations

61. Where there had remained a degree of opposition in the responses to the revised proposals, and in particular, the issue of the Dearne wards and the Penistone West ward, we considered that there was insufficient new evidence to warrant any further revisions to our proposals. However, we did consider that the name of the Wentworth and Dearne constituency was no longer appropriate as it had been significantly altered with neither the Dearne North, nor the Dearne South wards remaining in the constituency, and in our revised proposals report we specifically welcomed further suggestions for the name of the constituency. We therefore accepted a representation that suggests that the constituency should be called Wentworth and Hoyland, to recognise the existing element of the constituency, and the inclusion of the town of Hoyland.
62. Having considered the evidence and following discussions with the lead commissioner for this region we recommend no changes to the boundaries of the revised constituencies in this part of the sub-region. The names and composition of each constituency for the final recommendations is detailed in appendix A.
