Initial/revised proposals overview

1. The North West region was allocated 68 constituencies under the initial and revised proposals, a reduction of seven from the existing allocation. In formulating the initial and revised proposals the Commission decided to construct constituencies using the following sub-regions:

2. Under the initial proposals 14 of the existing 75 constituencies were unchanged. The revised proposals retained 13 of the existing constituencies unchanged, (a reduction of one). The theoretical entitlement of 25.37 constituencies in Greater Manchester and 10.34 constituencies in Cheshire meant that both counties had to contain constituencies that crossed their respective county boundaries. Under both sets of proposals it was proposed to have two constituencies that crossed county boundaries. We decided not to propose constituencies that crossed the Greater Manchester boundary in the north with Lancashire. The reasons for this are that there was no requirement for Lancashire to have a

constituency that crosses the county boundary with Greater Manchester and, even if this crossing had been proposed it still would be necessary to construct a cross-county constituency between Cheshire and Greater Manchester in the south.

3. We also proposed a minor cross-county constituency between Lancashire and Merseyside in the Southport constituency. This was done primarily to avoid dividing the town of Formby, and to allow more of the town of Crosby (which is currently divided) to be contained in a single constituency - our proposed Sefton Central constituency. In Cumbria and Merseyside (less the Wirral) it was possible to allocate whole number of constituencies.
4. In response to the consultation on the initial proposals and secondary consultation the Commission received over 3,000 representations regarding the North West region. These representations commented on most parts of the region, with the main issues being:
 - opposition to the proposed Lancaster and Morecambe and North Lancashire constituencies. Many rejected our arrangement and instead preferred the Conservative party counter-proposals for the North Lancashire region.
 - the proposed dissolution of the current Pendle and Ribble Valley constituencies, and the arrangement of the constituencies in the surrounding area. A large letter writing campaign was received from residents of Reedley ward requesting that the Commission return to the configuration they adopted at the 2013 review, where Pendle was kept together and the two neighbouring wards of Briercliffe, and Cliviger and Worsthorne were added to the constituency.
 - the inclusion of wards that comprise the town of Lytham St Annes in the initially proposed Blackpool South constituency, rather than the Fylde constituency; residents of the town expressed concerns that they would be marginalised in the new seat, and had no common ground with residents of Blackpool.

- the degree of change made to constituencies on the eastern side of the Greater Manchester area. There were particular objections to the division of Rochdale and Oldham boroughs; and also opposition to the initially proposed Failsworth and Droylsden constituencies.
 - the division of the town of Radcliffe between the initially proposed Bury and Farnworth constituencies.
 - the two cross-county constituencies of Altrincham and Tatton Park, and Bramhall and Poynton.
 - the names and composition of constituencies in the Wirral.
5. In forming their revised proposals for the North West, the Commission altered 27 (40%) of the initially proposed constituencies. Two of these constituencies were only subject to a change of name.

Number of representations received

6. In the North West region, the Commission received a total of 986 representations during consultation on the revised proposals, bringing the total number of representations for this region to 4,039. This number includes all those who gave evidence at the public hearings. There were also a number of duplicate representations within this total, as well as representations that made general comments that did not have any bearing on the substance of the initial or revised proposals.

7. While many of the representations can be categorised as opposing the Commission’s revised proposals, there has been a large degree of support for certain constituencies across the whole region. These include: all the constituencies in Merseyside and Cumbria, many constituencies in Greater Manchester, the City of Chester, Preston, South Ribble, and Stockport North and Denton.

Campaigns

8. As expected, throughout the region, representations from a number of organised campaigns were received. In the North West, these were as follows:-

9. During the previous consultations the Commission received 14 campaigns in relation to the North West region. The Commission received a similar set of letter writing campaigns (BCE-33223, BCE-33225, BCE-33227, BCE-41163, BCE-41164, and BCE-41165) regarding the Morecambe and Lunesdale constituency during the previous two consultations. At that time it received over 6,000 comments in relation to that campaign, with the vast majority of respondents opposing our proposals.

Major issues

10. Major issues that drew objection were as follows:

Cumbria

- in Cumbria, there were no issues that could reasonably be categorised as ‘major’; all of the proposed constituencies continue to be broadly supported.

Lancashire

- there continues to be strong opposition to the proposed Lancaster and Morecambe constituency.
- a number of representations continue to raise concerns over the large geographical size and lack of unity within the proposed North Lancashire constituency.
- there is still significant opposition to the Pendle and Ribble Valley constituency, with suggestions for a reconfiguration to create a constituency centered on the existing Ribble Valley constituency, and for the existing Pendle constituency to remain intact.

Merseyside (less the Wirral, including three West Lancs wards)

- opposition to the inclusion of three West Lancashire borough wards in the proposed Southport constituency. The inclusion of the three West Lancashire Borough wards of Hesketh-with-Beaconsall, North Meols, and Tarleton has been opposed to a greater degree than in previous consultation rounds. Those opposed to this constituency focused on the difference in nature between these three wards and the rest of the proposed constituency
- opposition to the dissolution of the existing Liverpool, Walton constituency

Greater Manchester, the Wirral, and Cheshire (Cheshire West and Chester, and Cheshire East)

- opposition to the proposed cross-county Altrincham and Knutsford constituency
- the division of the Heatons Wards between the constituencies of Stockport North and Denton and Stockport South and Cheadle
- the inclusion of the Ashton upon Mersey ward in the Stretford and Urmston constituency
- opposition to the configuration, and naming of constituencies in the Oldham Borough local authority area
- opposition to the naming of the Bebington and Heswall constituency
- opposition to the inclusion of the Audlem ward in the Crewe and Nantwich constituency

Final recommendations

11. In light the of the representations and evidence received we have considered whether the revised proposals should be changed.

12. The final recommendations have been formulated on the same sub-regions used as the initial and revised proposals. No counter-proposals that suggested alternative sub-regions were received during consultation on the revised proposals.

13. Under the final recommendations 13 of the existing constituencies are unchanged. As in the initial and revised proposals four constituencies are proposed to cross-county boundaries. Three of these cross-county constituencies remain unchanged from the initial and revised proposals, and we are proposing a minor ward change in the Bramhall and Wilmslow constituency.

Overview

14. In our initial and revised proposals, we divided the North West region into four sub-regions: Cumbria; Lancashire; Merseyside (less the Wirral); and Greater Manchester, the Wirral, and Cheshire (Cheshire West and Chester, and Cheshire East. In general, support was received for the creation of these sub-regions throughout all consultation periods. In the consultations on the initial proposals we received two counter-proposals that would alter our sub-regional arrangement. One respondent proposed a sub-region which would include parts of Lancashire, Merseyside, and Greater Manchester, and another respondent put forward a counter-proposal that suggested that we merge the sub-regions of Cumbria and Lancashire in order to address some of the issues in Lancashire. We rejected both of these arrangements as we did not consider that they enabled a better pattern of constituencies in the North West. In the consultation on our revised proposals, we received a counter-proposal in Cheshire that suggested we cross into the East Midlands region. This proposal was invalid in that it created a detached ward in Disley, and so was not considered when we formulated our final recommendations. We therefore recommend no changes to the sub-regions as part of the final recommendations.

Sub-region 1 - Cumbria

15. Of the six existing constituencies in Cumbria, none are within the permitted electorate range. Under our initial proposals the number of constituencies within Cumbria was reduced by one to give the sub-region a total of five constituencies. Significant changes were required to bring these five constituencies within the permitted electorate range.
16. We received broad support for the initial proposals in Cumbria, particularly for the proposed constituencies of Carlisle, and Penrith and Solway. It was suggested that the Bootle ward on the west coast, which we suggested should be included in the Barrow and Furness constituency, might more appropriately be included in the Workington and

Whitehaven constituency. There were also calls to include the ward of Dalston, which was proposed to be part of the Carlisle constituency, in Penrith and Solway.

17. We considered that Bootle ward did indeed look north for its services and community links and the initial proposals were amended, resulting in the transfer of Bootle ward from the Barrow and Furness constituency into the Workington and Whitehaven constituency. As was also proposed by some representations, the proposed name of the Workington and Whitehaven constituency was changed to the more appropriate West Cumbria.
18. We did not consider the case to transfer Dalston ward from the Carlisle constituency into the Penrith and Solway constituency to be sufficiently strong enough to warrant change; particularly in the light of considerable support for the proposed Carlisle constituency and representations that confirmed the integral nature of Dalston to the rest of the city of Carlisle. We therefore retained both constituencies as proposed in the initial proposals.
19. The consultation on the revised proposals attracted few representations in Cumbria. Many of the proposed constituencies continue to be broadly supported. The transfer of the Bootle ward from the Barrow and Furness constituency to the Workington and Whitehaven constituency did not prove to be contentious nor did the proposal to rename Workington and Whitehaven as West Cumbria. Opposition in Cumbria largely focused on the principle of the review itself and we did not receive any substantive counter-proposals for the sub-region.

Recommendations

20. Having considered the evidence received, and following discussions with the lead commissioner for this region, we recommend no changes to the boundaries of the revised proposals in this sub-region. We do not consider that any further compelling or new evidence has been provided that might justify changing the revised proposal constituencies. The names and composition of each constituency for the final recommendations is detailed in appendix A.

Sub-region 2 - Lancashire

21. Of the existing 16 constituencies currently within Lancashire, only three (Chorley, South Ribble, and Ribble Valley) have electorates that are within the permitted electorate range, and many of the remaining constituencies have electorates that are significantly lower than the permitted electorate range. In formulating our initial proposals we noted that Lancashire's entitlement to 14.06 constituencies meant that the county could have been treated on its own, but we proposed the inclusion of three West Lancashire Borough wards in a cross-county Southport constituency - primarily so that the town of Formby would not be divided between constituencies.
22. During consultation on the initial proposals a large number of objections were received in relation to the Lancaster and Morecambe constituency; perhaps the most contentious constituency in the North West. It attracted hundreds of individual representations from residents of both Lancaster and Morecambe. We received several sets of letter writing campaigns submitted by the Member of Parliament for Morecambe and Lunesdale, David Morris, and two further petitions signed by hundreds of residents from Lancaster. The main objection to the Lancaster and Morecambe constituency was that the two towns had distinct and strongly separate identities. The exclusion of Lancaster University, which is located in the mostly rural University & Scotforth Rural ward, was also a major point of opposition to the proposals. Several respondents, some of whom otherwise supported the initial proposals, considered the separation of Lancaster University from the Lancaster constituency to be unacceptable.
23. The level of opposition seen in Lancaster and Morecambe was not replicated anywhere else in Lancashire, nevertheless there were a number of issues which did attract significant comment. The North Lancashire constituency was not supported with many respondents commenting on the geographical size of the constituency, the lack of community links, and the number of local authorities that were contained within the constituency. In the boroughs of Ribble Valley

and Pendle the proposed Clitheroe and Colne constituency was widely criticised for its name, and long narrow shape. In the existing Ribble Valley constituency, there was concern that the communities within the existing constituency would be divided between North Lancashire and Clitheroe and Colne, which would result in a loss of the Ribble Valley and Pendle identity.

24. Generally, there was less opposition to our initial proposals in the south of Lancashire. The configuration of our Accrington constituency was largely supported, although some suggested the name Hyndburn would better reflect the areas contained within the constituency. Others suggested that there should be a ward swap with the proposed Burnley constituency. It was argued that Coal Clough with Deerplay ward would be better suited in the Burnley constituency and should be moved there; to compensate for this, Accrington would in turn receive the Rosegrove with Lowerhouse ward from the Burnley constituency. In Burnley the majority of respondents supported our proposals, there were however a number of respondents in the town of Nelson who were opposed to being taken out of a Pendle constituency and included in a Burnley constituency. The proposed South Ribble constituency was largely supported, although there were calls for the Bamber Bridge East ward, which had been included in the Clitheroe and Colne constituency, to be included in the South Ribble constituency alongside its partner ward Bamber Bridge West. There were also a number of suggestions that the Eccleston and Mawdesley ward should be included in the South Ribble constituency rather than West Lancashire.
25. We noted that at all stages of consultation there were relatively few representations received in reference to the proposed constituencies of Blackburn, Blackpool North and Fleetwood, Chorley, Preston, and Rossendale and Darwen with most representations broadly in support of our proposals.
26. In the west of the county, the principal issue of contention was the division of the St. Annes. The initial proposals suggested that the St. Leonards and Kilnhouse wards be transferred out of the Fylde constituency and into a Blackpool South constituency was met with widespread opposition. As well as the division of the community, many respondents in

St. Annes remarked that they felt no affinity to Blackpool, and did not share many common interests with its people. A number of counter-proposals were submitted which sought to address this issue.

27. In our response to the representations received during the initial proposals and secondary consultations, we did not consider that persuasive evidence had been received to justify Morecambe and Lancaster being placed in separate constituencies. We did however look at configurations which would have allowed the University ward to be placed in the constituency. The assistant commissioners recommended that the University should be included in the constituency, if additionally the Halton-with-Aughton ward was transferred to it, and the Bolton & Slyne ward was transferred out to the proposed North Lancashire constituency. Ultimately this proposal was rejected as it was noted that the resulting Lancaster and Morecambe constituency would have a geographically irregular shape, and appeared somewhat artificial.
28. We noted the concerns about the large geographical area covered by the proposed North Lancashire constituency but were able to compare it with other similarly sized constituencies in Cumbria; it was agreed that this was a natural consequence of sparsely populated rural areas. We did not consider the evidence and counter-proposals submitted to be persuasive enough to warrant change in this constituency. Having decided not to modify the proposed North Lancashire constituency meant that any changes to proposals in the boroughs of Ribble Valley and Pendle would have to be minimal. This meant that we did not recommend significant modifications to the configuration of Clitheroe and Colne constituency, as suggested by most of the counter-proposals. We sought to assuage some of the fears expressed over the loss of identity and suggested the constituency should be renamed to Pendle and Ribble Valley. We also considered that the transfer of Bamber Bridge East ward into the South Ribble constituency was desirable, as it unified the town in one constituency and had no knock on effects, so we recommended this change as part of the revised proposals.
29. Uniting the town of Bamber Bridge in the South Ribble constituency meant that we would not be able to include Eccleston and Mawdesley ward in South Ribble, as it would lead to the electorate being outside the permitted electoral

range. We considered that the ward could also be appropriately included in the Chorley constituency, noting that the ward is located in the Chorley local authority. There were multiple benefits to making this move: first, that the West Lancashire constituency would now be wholly contained within West Lancashire borough; second, that Chorley Borough would now only be divided between two, rather than three, constituencies as in the initial proposals; and third, that there are existing ties with the rest of the Chorley constituency. For these reasons we recommended that Eccleston and Mawdesley ward should be transferred out of South Ribble and into the Chorley constituency as part of the revised proposals.

30. We were persuaded by the argument that the Rosegrove with Lowerhouse ward had superior community links with Accrington and agreed with the view that residents within the Coal Clough with Deerplay ward would look more to Burnley for their services. We therefore recommended that these two wards be exchanged between the Accrington and Burnley constituencies as part of the revised proposals. We also noted that the majority of representations supported the view that the name Accrington would effectively represent the constituency, and suggested that this remain unchanged.
31. We investigated the counter-proposals which addressed the division of Lytham St. Annes between constituencies. One of them proposed an alternative arrangement of constituencies that would result in the Fylde local authority area being wholly contained in a single constituency. This proposal would also transfer the two wards of Breck and Carleton into the Blackpool North and Fleetwood constituency, and additionally include the Warbreck ward in the Blackpool South constituency. We noted that this would divide the town of Poulton-le-Fylde between constituencies but were persuaded by the evidence illustrating the division of St. Annes, as well as noting the physical division between the Kilnhouse and St. Leonard's wards and Blackpool, due to the presence of the airport. We therefore recommended that the constituencies of Blackpool North and Fleetwood, Blackpool South, and Fylde should be revised in accordance with this counter-proposal.

32. The revised proposals were generally considered an improvement over the initial proposals but there were a few issues which continued to attract significant opposition. There continues to be strong opposition to the proposed Lancaster and Morecambe constituency, a number of representations continue to raise concerns over the large geographical size of North Lancashire, and there is still significant opposition to the Pendle and Ribble Valley constituency. The Commission received a counter-proposal for this sub-region from the Conservative Party (a re-affirmation of their proposals for the county received in previous consultations) but it was supported and reiterated with added evidence by a number of others. This counter-proposal significantly reconfigures Lancashire and includes Morecambe and Lunesdale, Lancaster and Wyre, Ribble Valley and Hyndburn West, Pendle, Burnley and Accrington constituencies.
33. Additionally, we also received a counter-proposal from the Lancaster University Students' Union (LUSU), who considered that the University (located in the University & Scotforth Rural ward) should be included in the proposed Lancaster and Morecambe constituency, and suggested that either the Bolton & Slyne or Overton wards be transferred to North Lancashire in exchange.
34. Lancaster and Morecambe was again the subject of a campaign to see Morecambe remain in a separate constituency to Lancaster. With over 891 individual comments submitted, this campaign was smaller than those seen in previous consultations, but it still accounted for the vast majority of the representations received with regards to Lancashire. The representations largely reiterated views that had been expressed in previous stages of consultation. Residents in areas such as Carnforth and Silverdale, as well as others in the proposed North Lancashire constituency strongly opposed their inclusion in the this constituency, citing their lack of community links to other areas in the constituency, and their preference to remain in a Morecambe and Lunesdale constituency. These submissions implicitly endorse the Conservative Party counter-proposals. As in previous consultations, the proposed Lancaster and Morecambe constituency has also received support, primarily from those residing in Lancaster, although some respondents have still expressed concerns regarding the exclusion of the University from the constituency.

35. Once again, the Commission received strong objections to the Pendle and Ribble Valley constituency, with respondents arguing that this constituency had a lack of community focus, and irregular shape, and instead supported the Ribble Valley and Hyndburn West constituency that was put forward in the Conservative Party counter-proposals.
36. We had received some support for the name of the Accrington constituency in the previous stages of consultation; in the latest consultation, we noted that there was a significant number of representations still calling for the retention of the name Hyndburn. The rationale given noted that the existing constituency is Hyndburn, the local authority is Hyndburn district and Accrington does not reflect all of the main population centres in the area.
37. The transfer of the St. Leonards and Kilnhouse wards from Blackpool South into Fylde, thus reuniting St. Annes into one constituency, was almost unanimously supported. Some representations have however expressed opposition to the consequential division of Poulton-Le-Fylde between constituencies to facilitate these changes.
38. The Commission received no significant support or objection for the remainder of constituencies within Lancashire.

Recommendations

39. As will be outlined in the presentation to Commissioners, having considered the evidence and following discussions with the lead commissioner for this region, we are not persuaded by evidence received to modify the configuration of the revised proposals in this sub-region. The proposed Lancaster and Morecambe, North Lancashire, and Pendle and Ribble Valley constituencies have proven contentious since the initial proposals, attracting large numbers of objections to our proposals. Despite this significant opposition, we have not recommended modifying our proposals in this sub-region. We recognise that arguments here are finely balanced, and that changing the configuration for the proposals of these constituencies would not only lead to a disproportionate amount of change, but also result in unsatisfactory constituencies elsewhere. We consider that the reduction of two constituencies in Lancashire, and the fact that only

three existing constituencies are within the permitted electorate range (with many existing constituencies being significantly lower than the permitted range) meant that a large degree of change across the county was inevitable.

40. We note that the Conservative Party counter-proposal for constituencies in the north of Lancashire had already been submitted in earlier stages of the consultation, and we still do not consider this counter-proposal to be superior to our current recommendations, nor do we feel that sufficiently persuasive new evidence has been received to modify our proposals. While the counter-proposal does have its merits, we consider that the current proposals provide a superior pattern of constituencies across the county.
41. We carefully considered the case for the inclusion of the University in the Lancaster and Morecambe constituency, and we are not satisfied that persuasive new evidence has been received to change this proposal. We further note that in any case, both options put forward in the LUSU counter-proposal result in a constituency that does not meet the statutory requirements for the number of electors, and therefore can not be recommended.
42. Objections to the North Lancashire and Pendle and Ribble Valley constituencies were considered during our formulation of the revised proposals, and we have not received persuasive evidence to suggest we should depart from these proposals. We consider that the arguments put forward by the residents of Carnforth and Silverdale are similar to those heard in previous stages of the consultation, and while we recognise the strength of feeling against current proposals from these areas, we do not consider that the counter-proposal provides a better overall solution for Lancashire as previously stated. The division of Poulton-Le-Fylde is regrettable and has raised some concern, but we anticipated this might happen and made a judgement that the division St. Annes was more problematic. The small changes made elsewhere in places such as Chorley and South Ribble did not attract much comment, but when they did it was largely supportive. After carefully considering the representations received, we did however consider that Hyndburn was a more appropriate name for our Accrington constituency and we recommend that the name be changed. The names and

composition of each constituency for the final recommendations is detailed in appendix A.

Sub-region 3 - Merseyside (less the Wirral)

43. Of the existing 11 constituencies in Merseyside (less the Wirral), four are currently within the permitted electorate range: Garston and Halewood, Knowsley, St Helens North, and St Helens South and Whiston. Under our initial proposals we proposed to reduce the number of constituencies within this sub-region by one.
44. The revised proposals did not recommend any changes to constituency boundaries or their names on the basis that the initial proposals had been largely supported, and many of the representations that opposed them objected to the principle of the review rather than to specific proposals. The counter-proposals received for this sub-region were rejected because they involved large scale changes in Merseyside, Lancashire, or both, and we considered that many of these constituencies, particularly in Merseyside, had been supported.
45. Few representations were received in response to the consultation on the revised proposals for constituencies within this sub-region. The inclusion of the three West Lancashire Borough wards of Hesketh-with-Beaconsall, North Meols, and Tarleton were opposed to a greater degree than in previous consultations. Respondents from within the existing Southport constituency considered that the rural nature of these wards, contrasted the urban nature of the constituency, and that linking the two would be inappropriate. The proposed dissolution of the existing Liverpool, Walton constituency, and the resultant transfer of its component wards to other constituencies continues to be a point of objection, as does the proposed transfer of the Liverpool City wards of County and Warbreck to the Bootle constituency. There were no counter-proposals submitted for these constituencies in the revised proposals consultation, nor for any other constituencies in this sub-region.

Recommendations

46. Having considered the evidence and following discussions with the lead commissioner for this region we recommend no changes to the current proposals for any constituencies in this sub-region. We note the increased level of objection to the inclusion of the three West Lancashire Borough wards in the Southport constituency, but as examined when formulating our revised proposals, we consider that the counter-proposals that do not cross the county boundary are likely to result in the division of formby, and a mass reconfiguration of constituencies in Lancashire. Given that Merseyside has a reduction of one in the number of constituencies, we do not consider that persuasive new evidence has been received to retain a Liverpool, Walton constituency, and therefore recommend that all 10 constituencies as proposed remain unmodified. The names and composition of each constituency for the final recommendations is detailed in appendix A.

Sub-region 4 - Greater Manchester, the Wirral, and Cheshire

Greater Manchester

47. Of the 27 existing constituencies in Greater Manchester, 11 are within the permitted electorate range. Under our initial proposals, we proposed to reduce the number of constituencies in Greater Manchester to 25. Two of those constituencies were cross-county constituencies, which included wards from Cheshire. Since the electorates of many constituencies in western and central Greater Manchester were within the permitted electoral range, we sought to retain as many of these unchanged as possible. The remaining constituencies in this sub-region were subject to substantial change.
48. Response to the Commission's initial proposals in the Greater Manchester area was mixed. In the areas where constituencies were proposed either to be wholly or largely unchanged, the response to the proposals was fairly muted,

and any representations received were largely supportive. However, some representations suggested that the Commission's decision to retain many of these constituencies unchanged resulted in unsatisfactory constituencies elsewhere, particularly in areas such as the boroughs of Rochdale and Oldham, both of which contain a sufficient number of electors to contain two constituencies each, and in the case of the Rochdale constituency, remain unchanged. Some counter-proposals were received that modified the pattern of either wholly or minimally changed constituencies in order to address concerns in other areas.

49. In Bury, we noted a number of representations were concerned by the division of the town of Radcliffe between the initially proposed Farnworth and Bury constituencies, and several counter-proposals were received that re-unified the town into one constituency.
50. In the Borough of Rochdale, some respondents objected to any modifications to the existing Rochdale, and Heywood and Middleton constituencies, due to both having electorates within the permitted range, and suggested that these constituencies remain unaltered. The cross-borough constituency of Littleborough and Saddleworth was supported by some, but others considered a constituency with two different local authority areas to be undesirable, and also that the inclusion of the Saddleworth West and Lees ward in the Failsworth and Droylsden constituency divided Saddleworth between constituencies. A campaign was submitted urging the return of the ward to Littleborough and Saddleworth.
51. In the Borough of Oldham, many respondents expressed objections to the proposed Failsworth and Droylsden constituency, considering the inclusion of wards from the Borough of Tameside to be undesirable, and noting that the M60 motorway bisected the constituency. Counter-proposals received for this area included one which contained two constituencies wholly within the Borough of Oldham, and another that altered three constituencies in order to restore ties that had been broken. Other respondents opposed the division of Royton between the Oldham, and Littleborough and Saddleworth constituencies. In respect of the Manchester Central constituency, some respondents considered the

transfer of the Moston ward to the Oldham constituency to be inappropriate, given that the ward is administered by Manchester City Council, and the area had little connection to Oldham.

52. In the Boroughs of Tameside and Stockport, we saw a great deal of support for the the proposed Stockport North and Denton constituency, which was comprised of wards from the existing Denton and Reddish, and Stockport constituencies. However, the proposed Stockport South and Cheadle constituency was much less popular, prompting comments that suggested that the community in Cheadle was different to the industrial Stockport area to which it was proposed to be joined to. There were also objections to Heatons North and Heatons South being divided between the two constituencies. Many respondents also objected to the Marple and Hyde constituency, considering there to be little commonality between electors in each borough area.
53. It was generally accepted that it was necessary to form two constituencies that crossed county boundaries and that this had to occur in the southern part of Greater Manchester. That said, we received significant objections to the cross-county Bramhall and Poynton constituency, and noted that many respondents from Poynton did not wish to be included in a constituency with wards outside the county of Cheshire. We received counter-proposals that continued to link the two areas in one constituency with slight alterations. Further objections to the initial proposals in this area included the division of the towns of Handforth and Wilmslow, with several respondents additionally expressing their wish that these towns be included in constituencies based wholly in Cheshire.
54. We considered that there were competing approaches to the creation of constituencies in Greater Manchester. On one hand, existing constituencies within the western and central areas of the county could be largely unchanged, and modifications could be made elsewhere in areas where many constituencies did not meet the electoral requirements. Conversely, some of those constituencies which did not require change could be modified, so that those constituencies outside the electoral range could be changed to a lesser degree. In light of the evidence received, we decided not to make extensive changes to our initial proposals for Greater Manchester, opting instead to recommend alterations that

could be self contained, and did not adversely affect those constituencies which we suggested should either be minimally or wholly unchanged.

55. As noted above, we received a number of objections regarding the proposed Farnworth constituencies, namely to the division of the communities of Radcliffe and Whitefield. We were persuaded by evidence received in support of counter-proposals that transferred the Radcliffe East ward to a renamed Radcliffe and Farnworth constituency; that transferred the Pilkington Park ward to a Prestwich and Middleton constituency; and that also transferred the Unsworth ward to a Bury constituency.
56. In the boroughs of Oldham and Rochdale, we considered the evidence suggesting Royton and Saddleworth had both been split between constituencies to be persuasive, and recommended that the Failsworth and Droylsden, Littleborough and Saddleworth, and Oldham constituencies be modified so that both areas would remain undivided. We did not consider other counter-proposals, which suggested that the Oldham Borough Council area include two constituencies wholly within the local authority area to be persuasive, in light of the consequential effects on neighbouring constituencies.
57. We noted the opposition to the cross-county constituency Bramhall and Poynton. We considered that the Macclesfield and Bramhall and Poynton constituencies could be reconfigured to better reflect their communities. The three wards in the North comprising the towns of Poynton and Disley were returned to the Macclesfield constituency, whilst the four wards of Alderley Edge, Wilmslow West and Chorley, Wilmslow East, and Wilmslow and Lacey could be added to remaining wards in the Bramhall and Poynton constituency. This reconfiguration resulted in a new constituency we named Hazel grove and Wilmslow. The creation of this constituency had the added benefit of allowing us to unite the areas of Wilmslow and Handforth in a single constituency.

58. In response to the consultation on our revised proposals we received relatively few representations in reference to our proposed constituencies of Blackley and Broughton, Bolton West, Bolton North East, Leigh, Makerfield, Manchester Central, Manchester Gorton, Manchester Withington, Rochdale, Salford and Eccles, Worsley and Eccles South, and Wythenshawe and Sale East.
59. We received significant objections to the inclusion of the Ashton-upon-Mersey ward in the Stretford and Urmston constituency, with many respondents considering that the ward was in close proximity to Sale town centre, and others arguing that the area had no connection to either Stretford or Urmston, but rather to the rest of Sale and to Altrincham.
60. The small revisions we made in the boroughs of Bolton and Bury were generally supported although we did still receive a number of representations opposed to the suggestion of cross-borough constituencies. This was similar to the response seen in the Littleborough and Saddleworth constituency; while noting the inclusion of the Saddleworth and Lees ward as a marked improvement, many continued to oppose the combining of the two areas in a single constituency, noting that the proposed constituency contained electors from both Rochdale and Oldham local authority areas.
61. In the borough of Oldham, some respondents considered the inclusion of both the Royton North and Royton South wards in the Oldham constituency to be an improvement, but some respondents felt that the name of the constituency was not a true reflection of its composition. Some suggested that as the constituency contained the three wards that comprise Chadderton (Chadderton Central, Chadderton North and Chadderton South), that the name of the town should feature in the constituency. Others suggested that for similar reasons, the town of Royton should feature in the name of the constituency. Other respondents however, still considered both the Oldham, and Failsworth and Droylsden constituencies to be incoherent, and proposed alternative configurations for these constituencies.

62. In respect of our proposed Ashton-under-Lyne constituency, we received several representations from residents of Stalybridge expressing concerns about the inclusion of the town in the constituency, considering that they did not want their town's needs to be considered as an afterthought in comparison to Ashton-under-Lyne by the local authority. Many of these respondents also expressed the view that the existing Stalybridge and Hyde constituency was long-standing, and that while Stalybridge had formerly been part of Cheshire, Ashton had formerly been part of Lancashire and that many people still recognised this difference. Other comments received in reference to this constituency considered the absence of Stalybridge in the constituencies title to be unacceptable, and suggested its inclusion in the title to reflect the fact that Stalybridge is a sizeable town which covers a large geographical area.
63. We received three counter-proposals that addressed the issue of the division of the two Heatons wards between the constituencies of Stockport North and Denton, and Stockport South and Cheadle. One proposal was able to unite the Heatons by including both Heatons North and Heatons South wards in a renamed Cheadle constituency, and by transferring the Davenport and Cale Green, and Offerton wards to a Hazel Grove and Wilmslow constituency, and a renamed Stockport and Denton constituency, respectively. Other counter-proposals received transferred the Heatons North Ward to a Cheadle and the Heatons constituency, and made small alterations to the Commission's proposed Stockport North and Denton, and Hazel Grove and Wilmslow constituencies. The author of this counter-proposal subsequently put forward another submission, in which they disagreed with linking of the communities of Hazel Grove and Wilmslow, and considered a link between Cheadle and Wilmslow to be more appropriate. In order to do so and avoid major subsequent knock-on effects, they suggested that the Brinnington and Central ward be divided.
64. Our new cross-county constituency titled Hazel Grove and Wilmslow, received a mixture of support and opposition. Several respondents, particularly those from areas such as Poyton and Disley in Cheshire, supported the new configuration as it allowed them to remain in their current constituency. Other respondents were pleased with the unification of all the Wilmslow wards in one constituency, and were content that Alderley Edge, Handforth and Wilmslow were all contained within the same constituency. In contrast, we received further objections to the idea of a cross-county

constituency, with many respondents considering there to be no commonality between electors in the Stockport and Cheshire East local authority areas.

Recommendations

65. Having considered the evidence and following discussions with the lead commissioner for this region, we consider that compelling evidence has been received to modify the revised proposals in this sub-region. In the consultation on our revised proposals we received few representations in reference to our proposed constituencies of Blackley and Broughton, Bolton West, Bolton North East, Leigh, Makerfield, Manchester Central, Manchester Gorton, Manchester Withington, Rochdale, Salford and Eccles, Worsley and Eccles South, and Wythenshawe and Sale East. We therefore recommend that no amendments are made to these three constituencies.
66. In respect of the Stretford and Urmston constituency, we acknowledge that there are strong objections to the inclusion of the Ashton-upon-Mersey ward. We do not consider that other configurations of this constituency, and their subsequent knock on effects to better reflect the statutory factors, and therefore do not recommend any changes to this constituency.
67. We noted that there were a number of representations in the boroughs of Bolton, Bury, Rochdale and Oldham who were opposed to the principle of cross-borough constituencies. We have not received a counter-proposal which would allow us to propose alternative configurations in these areas, and the evidence we have received is not sufficiently persuasive to warrant an amendment of our revised proposals.
68. In respect of the Rochdale constituency, we are sympathetic to views that oppose changes to the existing configuration, but we do not consider that persuasive evidence has been received to amend our revised proposals for this constituency. We note that some respondents continue to oppose the Littleborough and Saddleworth constituency, as

described earlier. However, no counter-proposal has been submitted in relation to this constituency and we also note that there has been some support for the inclusion of the Saddleworth West and Lees ward in this constituency. We therefore recommend no amendments to the revised proposals for Rochdale and Littleborough and Saddleworth.

69. We were not persuaded by the evidence to reconfigure the Oldham, and Failsworth and Droylsden constituencies due to counter-proposals in this area being a significant departure from the revised proposals. However, we do, consider that persuasive evidence has been received regarding the naming the constituencies. We consider that the names of Oldham North, and Oldham South and Droylsden to better reflect the composition of these constituencies, and have therefore recommend that these constituencies are named as such in our final recommendations.
70. We noted the objections to the Ashton-under-Lyne constituency, which were primarily concerned with naming, and the inclusion of Stalybridge in the constituency. We do not consider that persuasive evidence has been received the modify the composition of this constituency, but we agree that Stalybridge is a significant settlement within the constituency, and this should be reflected in the name. Therefore, we propose that this constituency is named Ashton-under-Lyne and Stalybridge in our final recommendations.
71. Having carefully examined the counter-proposals for the Hazel Grove and Wilmslow, Stockport North and Denton, and Stockport South and Cheadle, and having considered the evidence received in relation to the division of Heatons North and Heatons South between constituencies, we consider that persuasive evidence has been received to modify these three constituencies. We recommend that the proposal that unites Heatons North and Heatons South wards in a renamed Cheadle constituency, transfers Davenport and Cale Green to a Hazel Grove and Wilmslow constituency, and moves Offerton ward to a renamed Stockport and Denton constituency is adopted as part of the final recommendations. We reject the counter-proposal that divides the Brinnington and Central ward, as we do not consider that this meets our exceptional and compelling criteria for splitting wards.

72. The names and composition of each constituency for the final recommendations is detailed in appendix A.

Wirral

73. Of the four existing constituencies in the Wirral, none are within the permitted electorate range. We proposed to reduce this number to three in our initial proposals. We suggested modest changes to the Birkenhead and Wallasey constituencies, transferring a single ward to each. We further proposed a Bebington and Heswall constituency that contained several areas from the existing Wirral South and Wirral West constituencies.

74. The initial proposals for Wirral received a mixture of support and opposition during the first two consultations. The opposition largely focused on the Bebington and Heswall constituency with representations predominantly objecting to the name of the constituency, and some also objecting to the exclusion of the Bebington ward from the constituency. In our revised proposals, we sought to address this issue by transferring the Bebington ward to the proposed Bebington and Heswall constituency, and then by transferring the Bromborough ward to the proposed Birkenhead constituency. We suggested no changes to the Wallasey constituency.

75. The revised proposals for the Wirral were broadly supported, but the naming of the Bebington and Heswall constituency continues to be contentious, even though the proposed constituency now contains the Bebington ward. A few respondents argued that it was inappropriate for the Bromborough ward to be included in the Birkenhead constituency as residents in the ward are different in nature to those elsewhere in the constituency. Several alternative names have once again been submitted for the Bebington and Heswall constituency, with many of them recommending that the name 'Wirral' should be included in the title. Many consider that the name Bebington and Heswall is only inclusive to areas in the southern part of the constituency and excludes areas such as West Kirby and Hoylake. Examples of names put forward in this consultation are Wirral, Mid Wirral, West Wirral, Wirral West and Bebington, and Hoylake and Heswall among others. No substantive counter-proposals were received in reference to constituencies in the Wirral.

Recommendations

76. Having considered the evidence and following discussions with the lead commissioner for this region we recommend no changes to the boundaries of the revised proposals in this sub-region. We consider the configuration of the three constituencies in the Wirral to be mostly uncontroversial, and do not consider that departing from the revised proposals would better reflect the statutory factors. We note that in any case, no substantive counter-proposals were received for any Wirral constituencies. We do feel that persuasive evidence has been received regarding the name of the Bebington and Heswall constituency, and as some respondents have suggested, recommend that this constituency is named Wirral West and Bebington. The names and composition of each constituency for the final recommendations is detailed in appendix A.

Cheshire

77. Of the 11 existing constituencies within Cheshire, two (Congleton, and Crewe and Nantwich) have electorates within the permitted electorate range. Under our initial proposals, we proposed to reduce the number of constituencies within this sub-region by one, due to its entitlement to 10.34 constituencies.
78. We received a mixed response to our initial proposals for constituencies in Cheshire. Our proposed constituencies of City of Chester, Congleton, Crewe and Nantwich, Halton, Warrington North, and Warrington South were generally supported. We received objections to the Eddisbury and Weaver Vale constituencies on the basis that they were too radical in terms of reconfiguration from the existing pattern, and also to our Ellesmere Port and Neston constituency on the basis that it included the Eastham ward from the Borough of Wirral, with many respondents considering residents of this ward to have strong links with the Wirral, and preferring that the ward remain in a Wirral based constituency. We received strong opposition to the two cross-county constituencies of Altrincham and Tatton Park, and Bramhall and

Poynton, and in both cases opposition on these constituencies focused on the lack of connection between residents from different boroughs in each constituency. In the case of the former, some considered that the River Bollin formed a barrier between the two, that the name was inappropriate given that Tatton Park is largely uninhabited, and that areas such as High Legh and Knutsford should instead be linked to Macclesfield. Many considered that our initial proposals for Bramhall and Poynton, and Macclesfield did not respect local ties in Handforth, Wilmslow, Poynton, or Disley.

79. As part of our revised proposals we reconfigured the Crewe and Nantwich, Weaver Vale, and Eddisbury constituencies, in order to create more cohesive constituencies that better reflected the communities in Cheshire. As part of this reconfiguration, we recommended that the Audlem ward be included in the Crewe and Nantwich constituency. Elsewhere in Cheshire, we modified our initial proposals for the Macclesfield constituency so that it largely resembled its existing configuration, save for the inclusion of the Chelford ward, and reconfigured the constituency that crossed the county boundary between Cheshire East and the Metropolitan Borough of Stockport. We proposed a Hazel Grove and Wilmslow constituency that united both the Handforth and Wilmslow areas in a single constituency and invited comment on the configuration of this constituency. We did not recommend changes to the configuration of any other constituencies in Cheshire, but suggested that the Halton constituency be called Widnes and Runcorn, and that the Altrincham and Tatton Park constituency be called Altrincham and Knutsford.
80. In response to the consultation on the revised proposals we received widespread opposition, particularly from residents of Crewe, to our proposals to include the Audlem ward in the Crewe and Nantwich constituency. These representations argued that the residents of the Audlem ward were different in nature to those from Crewe, and that they did not look to Crewe for their goods and services. Furthermore, they argued that both Crewe and Nantwich, and the Eddisbury constituency would be within the permitted electorate range if Audlem were to be in the latter. Very few representations were received from the Audlem ward itself, but those that were received suggested that the rural nature of the ward was at contrast with that of Crewe and that the ward would be more suitably included in an Eddisbury constituency. While the naming of the Altrincham and Tatton Park constituency has been welcomed, the constituency continued to receive very

strong opposition, particular in Sale as described earlier in this paper. Some respondents, particularly from High Legh and Knutsford, continue to express the view that these areas should be linked with Macclesfield. A counter-proposal was received that achieved this aim, and that reconfigured many constituencies within Greater Manchester and Cheshire, and also crossed the regional boundary into the East Midlands. In contrast, the proposed Macclesfield constituency has been largely supported, particularly in the Poynton and Disley areas where there was strong opposition to the initial proposals. We received a reaffirmation of a counter-proposal received during prior consultation stages that wished to divide a ward in the Borough of Warrington in order to align with local government ward boundaries. Whilst some representations considered that improvements had been made to the Eddisbury and Weaver Vale constituencies, others felt that the continued division of Northwich was unacceptable. We received a counter-proposal that united all of Northwich in one constituency, as part of a counter-proposal that reconfigured the Crewe and Nantwich, Eddisbury, Weaver Vale, and Widnes and Runcorn constituencies. We noted that in the Borough of Warrington, several respondents re-affirmed their support for the proposal to align local government ward changes, which would result in the division of a ward. The constituencies of City of Chester and Congleton were broadly supported by respondents to the consultation.

Recommendations

81. As will be outlined in the presentation to commissioners, having considered the evidence and following discussions with the lead commissioner for this region we recommend that with the exception of the cross-county constituency of Hazel Grove and Wilmslow, which has been discussed earlier in this paper, no further changes should be made to the boundaries of the revised proposals in Cheshire. We note that one of the major issues in Cheshire, the division of Northwich, is resolved by the counter-proposal received but we consider that the the changes put forward in this proposal are a significant departure from the revised proposals, and in the case of the Widnes and Runcorn, modify a constituency that we consider to be uncontentious. We regret that Northwich is divided in our proposals, but note that

the same is true in the existing arrangement of constituencies, and therefore recommend that this counter-proposal is rejected.

82. Similarly, we do not recommend the counter-proposal that reconfigures several constituencies in two counties, and crosses the regional boundary into the East Midlands in order to link the High Legh and Knutsford areas with Macclesfield. We note that we rejected other counter-proposals that linked Knutsford and Macclesfield when formulating our revised proposals, and that also note that the Poynton area would be split in this proposal. Additionally, we note the strong support for our proposed Macclesfield constituency, and do not consider that this counter-proposal allows for a better pattern of constituencies. Therefore, we suggest this counter-proposal is rejected. We note there is a counter-proposal that seeks to divide a ward in the Borough of Warrington in order to reflect local government ward changes. We consider that this situation will arise in several areas across the country, and that dividing wards in this area does not have any beneficial effects elsewhere. We do not consider this reasoning to meet our 'exceptional and compelling' criteria for dividing a ward, and recommend that this proposal is rejected. We do not consider that persuasive evidence has been received to depart from current proposals in respect of the Audlem ward, which we suggested should be included in the Crewe and Nantwich constituency. We note that very few representations have been received from the ward itself, and while its inclusion in Crewe and Nantwich has been strongly opposed by residents of Crewe, the evidence received does not compel us to deviate from our previous recommendations in this area.
83. We do recommend a slight adjustment in the configuration and the name of the proposed Hazel Grove and Wilmslow constituency as described earlier. We do not recommend any other changes to constituencies in Cheshire. The names and composition of each constituency for the final recommendations is detailed in appendix A.
