To Whom It May Concern,

I am writing today regarding the boundary changes that have been suggested by the Boundary Commission in the London Borough of Havering. My specific focus is on my support for the change that will move the Emerson Park Ward into the Romford Constituency. Having worked in the area for quite some time now I am glad to see these changes having been suggested by the Boundary Commission.

I believe this is the correct decision, as the Hornchurch and Upminster Constituencies must be made smaller to rebalance the constituencies. Given that much of the current Emerson Park ward used to be part of the Romford Constituency, it would appear sensible that this is the part that changes hands again in this rebalancing. The fact that it was as recent as 2010 that this area of Emerson Park was part of Romford, I believe also makes the changes sensible. Unlike other areas that may be moved from Hornchurch and Upminster, this area already has connections from recent history to the area that it would move into meaning that the change would be more seemless.

The strong community ties that exist between Emerson Park, Ardleigh Green and Gidea Park make it a perfect area to be moved into the Romford constituency. Emerson Park is a significant part of a continuous residential area that runs from the furthest part of Emerson Park to East Romford. It, therefore, makes sense to bring these areas back together into one constituency. This point was in part recognized in the changes to the ward boundaries in the area, with part of Emerson Park ward being transferred into Romfords Squirrels Heath ward. Surely, the logic that applied to that change is also relevant in the matter of the constituency boundary.

Furthermore, this community shares important transport links into Romford, with busses that run from Emerson Park, through Ardleigh Green and Gidea Park and into Romford. Romford is also only one stop from Emerson Park on a train that runs between the two regularly through the day.

This train line and the River Ingrebourne create a clear geographical boundary between the Romford and Hornchurch and Upminster Constituencies. This is important as it ensures that the constituency has one continuous community without the situation where two different people living on the same road are represented by a different M.P.

To whom it may concern,

I would like to write to the Boundary Commission for England regarding the 2023 review, to oppose the move to place Emerson Park ward into Romford constituency. The ward which is currently in Hornchurch and Upminster constituency would not fit into the Romford Constituency and, it has historic and cultural links to Hornchurch and Upminster, such as our local football team, Hornchurch business network, and shared common greenspaces, cultural centres such as our Queens theatre and Hornchurch Library.

I also think that the commission should acknowledge that Emerson Park is served by several key public transport links, and road links (such as Wingletye Lane, Butts Green Road and the A127) connecting to Hornchurch and Upminster, not Romford.

I strongly oppose this move and would request that this be changed, and that Emerson Park ward remains in Hornchurch and Upminster constituency. Attached below are our contact details signing and dating this letter of concern to you, asking for action on this matter.
