

The 2023 Boundary Review

Introduction

We are the Boundary Commission for England (BCE), an independent and impartial public body.

A review of parliamentary constituencies is taking place to ensure each one has roughly the same number of electors. As part of this process, the number of constituencies in England will increase to 543. The Commission is required by law to make sure that each constituency in England has between 69,724 and 77,062 electors, excluding two 'protected' constituencies for the Isle of Wight.

Due to population changes, the number of people registered to vote in some constituencies is much higher than in others. The 2023 Boundary Review will therefore rebalance the number of electors represented by each MP. It's an important process, and one which requires considerable change to the existing map of constituencies.

Our task is to redraw the map of constituencies in England so that it represents local communities as best as possible, while keeping to the legal requirements outlined above.

We want members of the public to tell us their thoughts on our proposed new constituencies, so we can improve them. This is where you come in. With your support, you can help us raise awareness of our secondary consultation and enable others to have their say on the boundary changes.

Our secondary consultation

We received a fantastic number of responses - over 34,000 - to our first consultation, which took place from June to August last year. From 22 February to 4 April 2022, we're holding a six-week secondary consultation on our initial proposals, and we want as many people as possible to have the opportunity to provide their views.

To have your say, you can send us your comments from 22 February in writing via our consultation website, <u>bcereviews.org.uk</u>, or by email or letter. These must reach us by 4 April 2022, when the consultation closes. You can give us your feedback on anything from where the proposed electoral boundaries are, to our suggestions for new constituency names.

We cannot accept any comments sent in before the consultation opens on 22 February. You are welcome to begin promoting the consultation before this date, but please be mindful of this restriction in your messaging.

We are also holding 32 public hearings across the country, where members of the public can provide their views in person. To find out the location of a public hearing in your region and book a 10 minute slot to speak, please visit the dedicated public hearings page on our website here: <u>bit.ly/bcepublichearings</u>.

Further information about the public hearings, including what to expect when attending a hearing, can be found in our <u>Guide to the public hearings</u> (available as an HTML webpage and to download as a PDF via our website).

We have also published the responses we received during our first consultation, so that people can take these into account when making a representation. These are available to view on <u>bcereviews.org.uk</u>.

What happens next?

After the secondary consultation has closed, the Commission will analyse every representation sent in during the first and secondary stages. We will produce a report deciding on whether the initial proposals should change and which details any suggested changes. Alongside this report, we will publish all the written representations we received during the secondary consultation, as well as the transcripts from public hearings.

If our proposals change, we will hold a further four-week written consultation on our revised proposals inviting you to tell us what you think about them. There will be no public hearings at this stage. Those comments will be published along with our final report, which will be sent to Parliament by July 2023 and subsequently made into law.

How to get involved

We have produced this pack to make it easier for you to get involved. We want to raise awareness of the 2023 Boundary Review as widely and locally as possible, to make sure that everyone has the opportunity to have their voices heard.

Help others to have their say by using your communication channels to spread the word. You could start by sending this resource pack to other organisations and representatives in your community, such as housing associations and parish councils.

Please think about how you can best reach every demographic in your community. For example, do you have a Diversity Officer who can assist you in spreading the word among underrepresented communities? To help reach those who don't have easy access to the internet, can you put up posters in local venues?

Here are some more ideas:

- Post our ready-made social media content, or design your own
- Include a brief paragraph in your newsletter or bulletin
- Publish our content on your organisation's website
- Distribute our posters and flyers to your offices and local venues, such as libraries
- Send a press release to your local media
- Email our factsheet to your stakeholders
- Spread the word among local community groups
- Follow us on social media (@BCEReviews) to keep up to date with the consultation, and share our content

The Boundary Commission for England (BCE) is required by Parliament to undertake an independent and impartial review of all constituencies in England, to rebalance the number of electors in each constituency. The 2023 Boundary Review also requires that the number of constituencies in England increases from 533 to 543. The Commission is holding a secondary consultation on its initial proposals for new constituencies, which takes place from 22 February to 4 April 2022. During the consultation, public hearings will be held across the country to allow members of the public to provide their views in person.

To have your say, submit your views in writing via the consultation website <u>bcereviews.org.uk</u>, by email, or letter; or speak at a public hearing in your region. Find your nearest hearing and book a slot to speak at <u>bit.ly/</u><u>bcepublichearings</u>. On the consultation website, you can also view and take into account the responses sent in during the first consultation.



FAQ

Read the answers to some frequently asked questions below. Still have questions? Get in touch - our team will be happy to help.

Why are you reviewing constituency boundaries?

The Boundary Commission for England has been asked by Parliament to rebalance the number of electors in each constituency. Due to population changes since the last review, the number of electors in some constituencies is much higher than in others. The 2023 Boundary Review will make sure each MP represents roughly the same number of electors (between 69,724 and 77,062). The number of constituencies in England must also increase from 533 to 543. The new map of constituencies proposed by the Commission therefore has significant changes.

Where can I see your proposals for new consituencies?

Visit our consultation website, <u>bcereviews.org.uk</u>, to view our proposals and take part in the consultation.

How do you develop your proposals for new constituencies?

We must keep to the rules set by Parliament, outlined above. We also take into account existing boundaries, local geography, and local ties. We know that local knowledge can help improve our proposals, and have invited the public to participate in our secondary consultation. We will take into account every response when deciding on any changes to our initial proposals. Read our <u>Guide to the Review</u> for further information on this.

Have your proposals changed since the first consultation?

No. After the secondary consultation has concluded, we will analyse the responses sent in and decide on any changes to our proposals.

Will this review favour one political party over another?

The Boundary Commission for England is independent and impartial and will not take into account patterns of voting or the results of elections when reviewing constituency boundaries. Nor do the political parties' views on where boundaries should be have any more weight than those of members of the public.

Will the changes affect my local council services - bin collections or schools, for example?

No. The boundary changes only relate to parliamentary constituencies (the area an MP is elected to represent in Parliament). Services and council tax in your local area are set by your local authority and this review does not change local authority boundaries.

What happens after the secondary consultation, and when would the proposed changes take effect?

We will analyse every response received during the first and secondary consultations. If our proposals change, we will publish our recommendations and hold a further public consultation. Our final recommendations will be submitted to Parliament by 1 July 2023, and the new constituencies will take effect at the next General Election thereafter.

Will the name of my constituency change following the review?

Generally, the more a constituency has changed, the more likely it is that the BCE will recommend a change of name. The Commission welcomes views on the naming of proposed constituencies during the consultation.

Should I submit my views in writing or in person?

You are welcome to attend a public hearing to provide a response in person or to send in a written representation via our consultation website, <u>bcereviews.org.uk</u>, or by email or letter, within the consultation period. We place equal weight on feedback submitted orally and in writing.

How can I attend a public hearing?

Go straight to our public hearings page on our website via this link: <u>bit.</u> <u>ly/bcepublichearings</u> and find your nearest hearing from the dates and locations listed. By selecting your chosen event, you'll be taken to Eventbrite to register for a 10 minute slot to speak at the hearing. Booking is a quick and easy process.

What happens at a public hearing?
