Thank you for your email request for information to the Boundary Commission for England (BCE) on 17 May 2024, which has been considered under the terms of the Freedom of Information Act (FOIA) 2000.

In your request for information you asked:

I am looking to find out about your commission's most recent boundary review.

- 1. The number of Members of Parliament who complained or offered comment about boundary review proposals between the initial proposals and revised proposals.
- 2. The number of Members of Parliament who had complaints about boundary review proposals between the initial proposals and revised proposals upheld or partially upheld.

BCE response:

- 1.The number of Members of Parliament for English constituencies who offered comment between the initial and revised proposals is 623. This figure is larger than the actual number of MPs and includes multiple responses and further submissions.
- 2. The Commission does not have the information you have requested as to whether complaints from MPs have been upheld or partially upheld. Responses to the Commission in opposition to its proposals from MPs are not considered or treated as complaints, but as responses to the public consultation process. The Commission does not specifically link the views or submissions raised in individual representations to its recommendations, and does not consider or categorise the comments from individual responders (whether they be from the public or an MP) as being upheld or dismissed.

Under our separate complains procedure, no formal complaints were received from MPs during the periods you have specified.

Under the provisions of the FOI Act, if you are dissatisfied with the response provided you may wish to ask for an internal review. If this situation arises you should write to:
