Thank you for your email request for information to the Boundary Commission for England (BCE) on 11 April, which has been considered under the terms of the Freedom of Information Act (FOIA) 2000.

Our response:

The Commission does not directly employ staff. During this period staff were employed by Cabinet Office and then by Ministry of Housing, Communities and Local Government. We do not hold any records of flights made by staff during these periods.

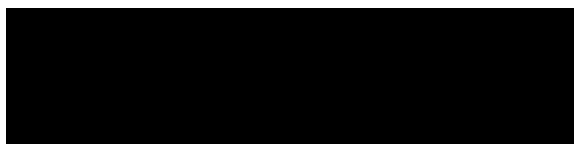
